- Engage in continuous professional development for the purposes of increasing the quality and depth of your work.
- Leading project planning sessions and managing project progress and adapt work as required
- Ensuring projects meet deadlines and managing relationships with clients and stakeholders
- Design risk mitigation strategies and conducting review and creating detailed reports for the executive staff.
