Welthungerhilfe in South Sudan has been implementing activities in nine locations in the states of Northern Bahr el Ghazal, Greater Equatoria and Unity since 2011, with its programs in humanitarian assistance, rural development, livelihoods, nutrition, food security, and WASH sectors. Currently WHH South Sudan implements 19 projects across South Sudan.

**Project background:**

Welthungerhilfe has implemented emergency and rehabilitation programs in Unity State from 1998 up to date with some breaks due to insecurity and funding challenges. Recently WHH signed a Field Level Agreement with WFP for the implementation of a Food for Assets project in Mayom County in Unity State. The project's overall objective is to contribute to improved food and nutrition security and strengthened resilience of shock-affected vulnerable households especially women and youth in Mayom County while reducing the prevalence of acute malnutrition at the community level.

**Job purpose:**

The Field Coordinator - FFA will work with the FFA staff, Government structures, WFP and other stakeholders to identify areas that have good potentials for FFA activities especially focussed on Food security and livelihood to build & enhance resilience for the community in Mayom in South Sudan. The Candidate will have a strong background in agriculture and have adequate experience and skills on FFA implementation.

### Key responsibilities:

- Plan, coordinate and provide technical oversight in the timely implementation of Food for Assets/Cash for Assets project activities.
- In coordination with MEAL Officer and Head of Project, support and coordinate food security & infrastructure related assessments as may be required.
- Attend Food Security and Cash Transfer coordination meeting and provide regular update to local government officials.
- Oversee Food and Cash Based Transfer activities under the FFA project.
- Ensure staff are oriented to follow and adhere to the activity Standard Operating Procedures (SoPs).
- Ensure that the WHH Complaints and Response Mechanism and Gender Mainstreaming strategy is incorporated in project implementation.
- Prepare accurate and timely Food for Assets related reports for review by the Head of Project.
- Provide field Management of FFA project staff in collaboration with the Head of Project.
- Represent the project with local authorities and other stakeholders in local engagements and during project visits by donor/HQ personnel/senior government officials.
