Purpose of the job.

The Project Officer will support the implementation of women peace and security, gender-based violence with a component of livelihood opportunity. She will work with the Project Manager and other implementing partners in the field to follow-up and take action on relevant activities

in a timely and effective manner. The incumbent will also be expected to undertake consistent follow up with key partner, women rights organizations and youth organizations, coordinate with local authorities and other key stakeholders ensuring timely implementation and reporting on project by staff under his/her supervision and partners. The Project manager will also be a focal person for Women, Peace and Security component. She/he will work closely with Country Gender and Protection Advisor to design strategy and extend support on WPS for CARE SSD

SPECIFIC RESPONSIBILITIES:

Responsibilities of the Project Officer include, but are not limited to, the following:

- Facilitate training to/ existing VSLAs, IGAs, using the Care approved VSLA methodology to promote entrepreneurship and livelihood options for beneficiaries and communities.
- Support the trained facilitators to effectively train VSLAs in savings and lending activities.
- Provide awareness to targeted households and VSLAs on cross cutting themes such as Gender, HIV /AIDS and Conflict Sensitivity
- Organize learning exchange visits between and among VSLA groups.
- Facilitate training of existing peace committees, peace clubs on their roles, principles, and conflict resolution mechanisms

- Develop Quarterly Cash Forecasts and Manage Cash Advances as well as Liquidating the Expenses timely.
- Submit reports timely to the project manager/ Area manager.
- Implementation of general protection, women leadership program, peacebuilding and ensuring technical quality and standards are considered and respected during the project implementation including but not limited protection monitoring, awareness raising and sensitization, community-based protection approaches, peacebuilding, and capacity building.

- Take the lead in preparing all field related reports of conducted activities including according to the project implementation matrix.
- Facilitate harmonization and dissemination of national guidelines and treatment protocols for life saving procedures in relation to COVID 19 pandemic response under the high-level task force.
- In collaboration with Monitoring and Evaluation (M&E) Manager, support project monitoring and evaluation in coordination with the project assistants, partners, and beneficiaries during project activity implementation.
- Ensure the project is implemented in accordance with relevant coalition for humanity technical guidelines and standards.
- Ensure the proper project budget utilization and physical targets achieved are reviewed throughout the project implementation period.

Communication, Engagement and Advocacy

- Participate actively in contributing to documentation of 'success stories' and other information to demonstrate results/impact of initiatives undertaken by CARE staff and partners and enhance the overall quality of performance reports to all constituents.
- Develop strong networks with international (INGO, UN, Donors) and national actors (Government, Think Tanks, Civil Society) around key peace building/conflict resolution issues including gender, and women leadership which is central to CARE program. This includes developing mutually beneficial partnerships to support joint messaging and influencing strategies with international and national actors.
- Contribute to research and writing of reports and briefings on relevant peacebuilding, women leadership and advocacy development issues in South Sudan.
- In the absence of the Project Manager, the project officer will represent CARE at meetings, conferences and seminars related to the peace building, Gender protection and advocacy

Required Qualifications

- 3 years plus administration or project management particularly in the field positions is desirable.
- Extent and relevance of experience in Programme/project formulation, analysis, implementation, and monitoring.
- Ability to develop plans for the implementation and coordination of project operations in Juba and fields.
- Understanding of economic empowerment / peace building advocacy methodologies and content.
