Are you passionate about advancing career in Program Unit? Join our motivated and talented Shejeh Salam team as a Regional Program Director (RPD). This is a great opportunity for a Regional Program Director that is looking to progress his or her career with Shejeh Salam Program Unit.

## Activity/ Project Background:

Under contract with the U.S. Agency for International Development (USAID), DT Global South Sudan is implementing the five-year, Shejeh Salam Activity in South Sudan Shejeh Salam Activity that is building the foundation for a more stable and socially cohesive South Sudan that will enable local actors to build community cohesion to promote peace processes and peaceful co-existence; civil society actors to advocate for peace and reconciliation and participate in civic processes; provide trauma awareness services to communities; and access to media that is providing accurate, fair and thorough information to mitigate the impact of rumor and misinformation. Shejeh Salam Activity currently programs in Juba, as well the USAID's priority states of Unity, Western Bahr el Ghazal, Upper Nile, Greater Jonglei, and Eastern Equatoria, although geographic focus may shift.

#### **Position Summary:**

Shejeh Salam is a Regional Program Director that will provide day-to-day management oversight of a Shejeh Salam field office in all areas of project representation, grant development and implementation, staff management, as well as oversight of finance, procurement, and security for the field office. The RPD for greater Jonglei will lead Shejeh Salam's presence in the two counties of Kapoeta North and Budi and will be based in Kapoeta.

## **Duties and Responsibilities:**

- Provide up-to-date and informed regional analysis through field visits, maintaining key relationships and contacts throughout the region, and monitoring changing dynamics to support the development of a contextually sound grant portfolio
- Interface directly with USAID for briefings and in-field missions, often as the primary representative of Shejeh Salam
- Lead community consultations on grants being implemented in their areas to ensure views are incorporated throughout the project life cycle, and participation is enhanced to promote the sustainability of project results/outcomes
- Lead and coordinate the development of regional grants for local partners in the fields of peacebuilding, civil society/civic engagement, trauma awareness, and media. Incorporate feedback from team members, senior management, and USAID in the course of grant development
- Lead programming: planning, development, implementation, monitoring and evaluation and organizational learning linked to the regional grant portfolio
- Oversee relationships with local non-government organizations (NGOs) implementing grants; monitor performance and ensure grantees are achieving the agreed upon milestones
- Lead and champion mainstreaming of cross-cutting themes such as gender, inclusion, youth, environment, protection, gender-based violence and conflict sensitivity

- Organize and hold regular planning meetings in the regional offices to ensure regular activity status reviews are conducted, challenges are identified and addressed, and tasks assigned as appropriate
- Build and maintain working relationships with international and national NGOs, community-based organizations, community members, authorities, local governments, and other key stakeholders within the region
- Represent Shejeh Salam in the regional working groups, coordination clusters, community and/or government coordination meetings
- Respond to and/or resolve problems arising from partners or beneficiaries in a timely fashion and in close coordination with the project risk manager and the Senior Management Team (SMT)
- Support the management team with coaching and professional development of the field staff through face-to-face meetings, feedback through staff performance appraisals and training/support as needed
- Leads enforcement and implementation of donor compliance and reporting for the regional office; as well as provide oversight of regional procurements to ensure they are reasonable, allowable, and allocable
- The RPD will continuously and extensively explore and map out opportunities in the region to establish a strong, diverse, and representative base of partners from the USAID priority counties.
- Any other tasks as assigned by your supervisor or Chief of Party

- Demonstrated problem solving and analytical skills and good judgement
