Its programme areas include Integrated Community Case Management (ICCM), Boma Health Initiative, Nutrition for children under five years of age, health systems management, and LLIN mass distribution. I We also work with the MoH on policy and guideline development. These programs are currently funded by UNICEF, Health Pooled Fund(HPF) and Global Fund.

The Health Pooled Fund is a consolidation of funding from the British Government's Department for International Development (DFID), the Government of Canada, the European Union, the Swedish International Development and Cooperation Agency (SIDA), and the United States Agency for International Development (USAID) and aims to support the Government of South Sudan in reducing maternal and infant mortality, ensuring universal coverage, and improving the overall health status as well as the quality of life of the South Sudanese population.

The Health Pooled Fund is based on a county model, whereby support is provided to the county health departments for the delivery of Primary Health Care services, health system strengthening and strengthening of community ownership.

The Essential Health Services Project (EHSP) is funded by UNICEF and aims to support the Government of South Sudan in reducing maternal and infant mortality through the delivery of low cost, high impact essential health services to about 2 million of the population living in the former Upper Nile and Jonglei States. The EHSP is based on a county model, whereby support is provided to the county health departments for the delivery of Primary Health Care services, health system strengthening and strengthening of community ownership.

# Scope of work

The Driver is responsible for the transportation of staff and goods for one location to another as needed. He/she will ensure cleanliness of the car daily performance checks, reporting repair needs and carrying out minor repairs.

## **Key working relationships**

The Cleaner will contribute towards ensuring a clean and safe working environment with staff and providing water and tea for staff in the office.

#### Key accountabilities

### Cleaning (80%)

- Clean equipment, furniture, walls, toilets and Office premises on a daily basis and ensure there are toiletries in the toilets at all times.
- Launder clothes for staff in the guest house in locations where there are guesthouses.
- Clean the staff rooms and ensure the linen are changed on a regular basis.
- Thorough clean water filters and the fridges on weekly basis and ensure there is a stable supply of clean drinking water for all staff in the office
- Ensure there is boiled water in the flask in the Office every day for staff tea and clean the tea cups regularly during the day as they are used by the staff.
- Monitor the cleaning materials and tea items for the office and report when the stock is low for replenishing.
- Ensure that the office waste is well disposed by shredding, burning or handing it to the city council designated places.
- Perform any other duties assigned to you by your line Manager
