#### **Position Summary**

The Nutrition Officer will support Maban Host Community program in provision of nutritional services TSFP/ OTP/ Outreach sites. This includes Monthly report collection, supportive supervision, and demonstration of right MUAC screening to Nutrition staff and training as well as management of CNVs including other volunteers. He also oversee the MIYCN activities including the Counselling to mothers and caregivers.

## Roles & Responsibilities:

- Conducting supportive supervision to nutrition activities in all Nutrition sites in Maban host community.
- Directing and informing nutrition Assistant and OTP nurses to do their work.
- Assist the OTP and TSFP staff during MUAC screening and monthly reporting
- Mentors and coach the nutrition staff on different nutrition reporting templates
- To ensure Volunteers activities are taking place in outreach sites like MUAC screening, referral of cases and defaulters with proper use of referral forms
- Advice Nutrition Assistant to submit timely monthly reports.
- Conduct CMAM / MIYCN and supply training with support from Senior Nutrition officer.
- To ensure that the supply are requested on time and accounted for by end of every month

- He/ she to ensure that there is use of stock cards in all nutrition store including in the main ware house at the facility.
- To ensure that there is monthly inventory of nutrition supply and share with senior Nutrition officer.
- Ensure all nutrition sites have proper waste disposal so that waste management areas are not filthy with waste from the facility.
- To ensure CNVs conduct home visits to counsel mothers and caregivers of children less than two years on MIYCN.
- Conduct meeting with Nutrition staff and answers issues related to work or report to field management what requires higher attention.
- To participate in planning and undertaking nutrition surveys, rapid assessments and campaigns respectively.
- Participate in providing updates on Covid-19 response on weekly or bi-weekly level
- Any other duties as assigned from time to time.

### Confidentiality

- Ensuring the non-disclosure of any information whatsoever relating to the practices and business of RI acquired in the course of duty, to any other person or organization without authority, except in the normal execution of duty.
- Protect patient and beneficiary information.
- Required to cover for colleague in other duty stations as needed.
