## **POSITION SUMMARY:**

The epidemiologist works in the data management as the technical person who monitor the day to day data collection, analysis, interpretation and use for decision making. The Epidemiologist will closely work with the data management unit in charge and planning chief. The epidemiologist will mentor and coach the data management officers and data clerks within the data management unit. The incumbent is also expected to ensure that the daily and weekly EOC reports are prepared and shared to stakeholders in time.

## **MAJOR ACCOUNTABILITIES:**

In working closely with & under the supervision of data management unit in charge at the data management unit of the PHEOC, the incumbent is responsible for the following duties.

- Analyze and gain insights into the current state of COVID 19 data.
- Standardize data with user defined dictionaries and pre-built dictionaries.
- Ensure accurate data management systems in the PHEOC
- Identify key data assets, define and describe each attribute.
- Establish metrics driven trusted data processes and policies in consultation with the EOC management
- Demonstrate measurable return on investment on data governance investments
- Support implementation of operational quality standards within the EOC in consultation with the DMU in charge
- Support the establishment of metrics driven trusted data processes and policies.
- Demonstrate measurable return of investment on data governance investments.
- Attend EOC briefing meetings, data management TWGs, EPI/Surveillance TWGs when the DMU in charge is not around
- Support to ensure the EOC daily and weekly reports are prepared signed and shared timely with stakeholders
- Support the DMU in charge to ensure data security and confidentiality at all levels of data management
- Mentor and provide TA to data management officers and other staff within the DMU

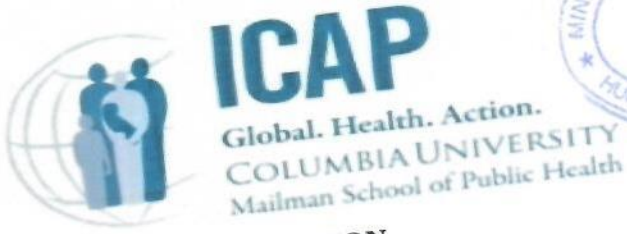
