OVERVIEW OF THE POSITION

Purpose of Activity/Assignment

- To supervise case management services throughout South Sudan.
- To build the capacity of UNICEF's Child Protection partners to deliver high quality case services to the most vulnerable children in South Sudan.
- To provide case management services alongside government and CSO social workers to children when critical issues arise, and tertiary level support is required.

Background & Rationale:

South Sudan is a country with a weak and fragile protective environment, making vulnerable populations such as women and children susceptible to abuse, neglect, deprivation, and exploitation. The transition from a protective environment founded on armed struggle to one based on laws and policies intended to safeguard citizens' rights is challenging. This transition requires social change, led by South Sudanese citizens, to build a peaceful protective environment. UNICEF is working with the government and civil society organizations to prevent all forms of violence, mitigate the worst effects of violence, and respond with services for survivors. The program will recruit 9 Child Protection Officers who will respond to quick onset emergencies, implement evidence-based methodologies to change social norms, providing case management, mental health and psychosocial support services to traumatized children, and engaging in policy and legislative enhancements to build durable child

protection systems. Ultimately, the program aims to move beyond the evils of war and violent conflict towards a South Sudan that protects every vulnerable group.

Scope of Work:

The Child Protection extenders will have the basic function to ensure case management support for all children at risk of, or surviving from, significant, violence, deprivation, neglect, exploitation including children on the street, children with disabilities, children without parents, children who are being deprived of basic rights at the household level, children suffering physical or sexual abuse or exploitation and any other cases demonstrating significant protection threats. The Child Protection Extenders will also provide case work supervision within UNICEF child protection partners throughout South Sudan and develop effective case work supervision within our partner organizations. They will build capacity in case management through a range of mentoring, coaching, training, supervision and active case management processes. In critical cases, the CP extenders will do case management in partnership with govt and NGO partners, taking responsibility to make sure that critical interventions are taken in a timely manner and in accordance with the best interests of the child. They will work under the technical supervision of the Child Protection Manager and the day-to-day supervision of the Child Protection Specialists and officers.

UNICEF's ambition with the CP extenders is that they will build effective professional habits in case management, case supervision, case follow and peer-based care for social workers. With effective case management mentoring and supervision, we will see positive results for children experiencing child abuse, neglect, deprivation or at risk thereof.

Main Duties and Responsibilities

Implement case management systems in area of operation with government and NGO partners.

- Conduct weekly case conversations with each agency under supervision [with programme manager, senior social workers, case workers]
- Support the case supervisors in the supervision of the implementation of case plans, including follow
 ups and case plan revisions. Including keeping oversight of all cases that have been opened by the
 organization.
- Support the case workers and supervisors in monitoring the effectiveness of the case management implementation.
- Support the case workers and supervisors in trouble shooting complex cases through consultations
 with case managers, case workers and relevant stakeholders. Taking on cases when the complexity of
 the case exceeds the capacity of case workers.
- Support the case supervisors in their duty of care for case managers and case workers.
- Accompany case workers to identify hard to reach children in need within the communities.
- Lead the quarter updates of the referral pathways and share them with the case management task force.
- Provide mentoring to LNGO case workers by conducting activities that support case identification of specific children at high risk including children on the street, children in conflict with the law, children with disabilities, children being groomed for marriage, and children out of school.

- Ensure effective data management with CP partners.

- Prior experience in child protection program development within a UN agency or organization is an asset. Having experience in both development and humanitarian contexts is also an advantage.
