Instructions to suppliers

Dear Supplier.

If you are interested in this tender, then you are asked to come to CEDS office and pick the tender documents and then:

- 1. Read the item specification (tab 2) and the evaluation criteria (on this tab)
- 2. Read the Terms and Conditions of the Contract, Ethical Code of Conduct & ECHO Principles (on tab 3)
- 3. Complete the Supplier Form (on tab 4) this is mandatory and submit together with your bid.
- 4. Prepare your tender offer and include all the information and documentation requested (including copies of your company's registration document). Failure to do so may result in the rejection of your tender. All prices quoted for the service should be in USD and should be exclusive of Value Added Tax (VAT) or other locally applicable taxes.
- 5. Put all of your tender information in a closed envelope and return to the above address to arrive no later than 10th of December 2022. Envelopes are to be clearly marked with the reference: CEDS-Juba-2022-JB11/22/11. You can submit your document both in Juba and Aweil field office. You will be required to register in a book at the gate on submission of your tender
- 6. Any queries about this tender should be addressed in writing to martin.omong@cedss.org and copies of all questions asked by suppliers and all responses will be provided
- 7. Suppliers may submit a tender for some or all items according to their capacity to supply. CEDS reserves the right to contract one or more suppliers in any combination. CEDS is not bound to accept the lowest offer or any offer.
- 8. CEDS are in no way responsible for any costs associated with preparing the tender response.

How does CEDS decide who wins the Contract?

- 1. CEDS will hold an Evaluation Committee made up of at least 5 members
- 2. CEDS will evaluate tender responses on the evaluation criteria set out below, as per the information requested as part of the tender process
- Following completion of the evaluation procedure, the successful service provider will be contracted to provide the service
- CEDS reserves the rights to select multiple supplier to speed up the actual procurement process
 The unsuccessful suppliers will also be notified. CEDS is not obliged to justify or explain selection to any respondent.

Evaluation Criteria

The following criteria will be used to judge your tender against the tender received from other suppliers. The below references will be used throughout the document.

- a. Pricing of the required items
- b. Terms of payment
- c. Ability to deliver the required items (Evidence of financial ability)
- d. Past Experience (proof for doing similar supply)
- e. Vendor profile
- f. Copy of valid registration certificate
- g. Copy of valid business operation licenes
- h. Copy of valid tax clearance
- i. Period required for completion of implementation
