## PRE-QUALIFICATION INSTRUCTIONS TO VENDORS

1. OFAO- South Sudan herein referred to as the organization, requests Companies who meet the criteria set out by the organization to apply for registration of Pre-qualification.
2. The Pre-qualification objective is to support OFAO-south Sudan through the provision of activity categories above under the relevant tenders/quotations to OFAO-south Sudan on and as when required during the stated



period.

3. Duly registered Vendors of goods, services and works under the Laws of South Sudan are invited to submit their Pre-qualification documents to OFAO-south Sudan, the prospective suppliers are required to provide mandatory information for Pre-qualification.
4. Prospective suppliers, Service providers, and contractors must have carried out successful supply and delivery of similar items/services/works to NGOs, Embassies, Institution, and Government of similar size. Potential suppliers/service providers/contractors must demonstrate the willingness and commitment to meet the Pre-qualification criteria.
5. This invitation of proposal for Pre-qualification is open to potential applicants who are able to demonstrate proven technical, financial and managerial capacity to provide the listed category of supplies/services/works.
6. This document includes vendor Registration form, Supplier Code of Conduct, and documents required of prospective suppliers.
7. The successful applicants will be registered on OFAO-south Sudan supplier Database for the period 2024 – 2025 and the organization will only deal with the Companies that are registered.
8. A Framework Agreement shall be entered into with successful vendors under a definite period.
9. Applicants must submit a dully completed and signed Supplier registration form provided herein as
10. OFAO- South Sudan reserves the right to request the submission of additional information from applicants or from any other credible source, and to visit and inspect the business premises of the applicant to verify the information given.
11. OFAO-south Sudan will ensure information that is received from companies is treated with the utmost confidentiality and shall be for the sole use of OFAO-south Sudan.
12. The pre-qualified vendors are required to immediately advise the OFAO-south Sudan of any significant change in its financial, technical capacity, ownership or holdings it may have undergone.
13. Failure to submit any of the mandatory requirements will lead to automatic disqualification from the exercise.
14. All vendors shall be subjected to a mandatory Vetting through an OFAO –south Sudan Member Check Appagaint EU, UN, OFAC, & South Sudan list of Sanctions for Terrorism and Money Laundering.
15. OFAO –south Sudan has a Zero tolerance to Sexual Exploitation, Abuse and Harassment (PSEAH). Any Vendor or its staff known to have committed such crime before, during, and/or in the future while doing business with OFAO –south Sudan shall lead to automatic disqualification and thus blacklisting of the vendor.
