Under the supervision of the field team leader, the Social Mobiliser will work with communities including stakeholders to ensure the right beneficiaries are selected for SCOPE enrolment

### Duties & Accountabilities

- Promote organization mission and values at all level and adhere to the UN code of conducts; mindful of Hold the Child policies and standard operation procedures (SOPs).
- Collaborate with site team leaders, WFP IPs (partners) and stakeholders to mobilise communities for scheduled SCOPE enrolment days
- Support beneficiary screening processes in compliance to WFP SCOPE enrolment criterion
- Ensure smooth workflow through the SCOPE enrolment cycle and orderly outreach site activities (crowd control)
- Work with Hold the Child's adopted Complaint, Referral, Tracking, and Feedback, Mechanism (CRTFM) during SCOPE enrolment field outreaches
- Conduct feedback sessions with beneficiaries including focus groups
- Complete daily and weekly area activity reports and submit to the team leader
- Adhere to codes of conduct in all activities (e.g., UN Code of Conduct for the prevention of sexual exploitation and abuse and Hold the Child, Child Protection Policy), needs of

vulnerable people, violations of human rights, child rights and women's rights (i.e., international conventions), and reporting mechanisms.
