## 1.1 Description of the Organization and its activities

The Johanniter International Assistance is part of the German NGO Johanniter-Unfall-Hilfe e. V., founded in 1952. Globally, the organization focuses on three areas; Primary Health Care, and Disaster Response and Preparedness.

The overall objective of the Johanniter in South Sudan is to contribute to the efforts of the Ministry of Health to reduce mortality and morbidity of mothers, children and other vulnerable groups. The interventions are aimed to improve access to quality primary health care and improved nutritional status of children under five, pregnant and lactating women and other vulnerable people. Improved access to water, sanitation, and hygiene is also an essential part of Johanniter's programming in South Sudan.

The Johanniter International Assistance(JUH) also referred to as the procuring Entity invites sealed tenders from eligible firms for the provision of security services for its offices in Juba and Wau. The contract will be for a period of two years with effect from 1<sup>st</sup> January 2020 to 31<sup>st</sup> December 2021 the period may be extended for another two years subject to performance which shall be reviewed at the end of the initial period.

Therefore, companies that are able to provide security services and meet the required standards as shall be stipulated by The Johanniter in the accompanying documents are encouraged to participate in this activity and a complete set of tender documents may be obtained by interested candidates from the Johanniter International assistance logistics office at the address mentioned above during working hours from 8am to 5pm. Monday to Friday.

The Companies submitting their bids must sign a declaration document for bidders and the open Tender Dossier will be distributed to the companies who will request for tender through the logistics department in The Johanniter offices in Juba or Wau office.
