

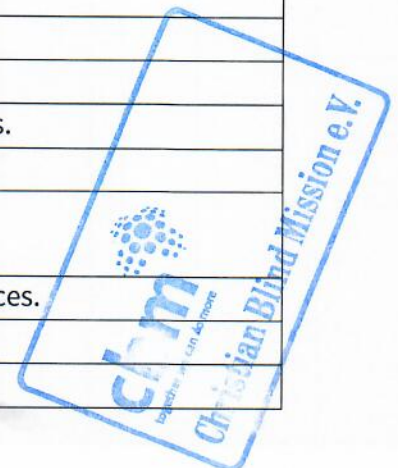


REQUEST FOR PROPOSALS FOR PRE-QUALIFICATION OF SUPPLIERS FOR GOODS AND SERVICES(Re-advertisement):

CBM (Christian Blind Mission International) is an international Christian development organization whose primary mission is to improve the quality of life of people living with disabilities in the poorest countries around the world. CBM works with persons with disabilities, their families, local partner organizations, and alliance partners including national and local Governments, UN agencies, international and national non-governmental organizations, and Disabled Persons' Organizations (DPOs). The CBM South Sudan Office works together with CBM International Office and Member Associations, in a joint and unified effort to implement development programmes in the areas of access to healthcare, rehabilitation, education and livelihood for people with disabilities, their families and communities in the poorest parts of the world.

Wherever possible CBM works through partner agencies, faith-based, secular and government agencies. We seek to enable our partners to increase and improve their services for people with disability, ultimately becoming self-sufficient in human and financial resources. CBM seeks to invite interested and eligible organizations to submit applications for the pre-qualification of suppliers for a 2-year period to 30th June 2023. This is a re-advertisement and need not apply if you had already submitted an application.
