Submission of bid documents: The bid documents should be submitted in a sealed envelope but preferably through above emails given the urgency, indicating the above Tender Ref. and written "Only to be opened by the tender committee on the 19th September 2023". The bids should be submitted from 12th September 2023 to 18th September 2023 during working days and hours (8:00am - 5:00pm) South Sudan local time. The bid can only be submitted by email due to the urgency of the power need or through Submission by email e-Tendering.
3. DELIVERY CONDITION: DDP-(Incoterms 2021) – Mvolo -Republic of South Sudan.
4. Delivered duty paid is a delivery agreement whereby the seller assumes all the responsibility of transporting of vocational training materials, and any other tasks associated with this supply. This includes paying for shipping costs, export and import duties and any other taxes.
5. DELIVERY PERIOD: As it will be agreed in the contract (Please note that quantities may vary at any time of ordering).
