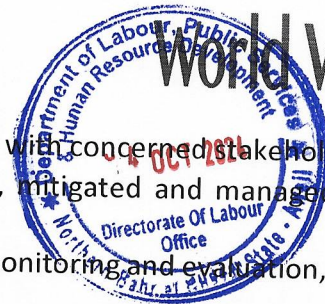
Purpose of the position:

The consultancy work will start as soon as possible and all the processes must be completed **within 40 days** of signing the contractual agreement, thus for the first year of the Project implementation. The timeframe includes submission of reports. The Consultant is expected to also work for 20 days each, during year 2 and year 5. The task is very time sensitive, and hence in the work plan the International Social and Environmental Safeguards Expert should present in detail how he/she will adhere to this timeframe.

ROLES AND RESPONSIBILITIES:

The Local Social and Environmental Safeguards Expert will work with, and assist the International Social and Environmental Safeguards Expert to ensure the following deliverables are met:

- 1) Provide a detailed Inception Report.
- 2) Develop monitoring and reporting site specific social and environmental safeguards including environmental impact assessments where needed.
- 3) Develop and coordinate implementation of all social safeguard related plans.
- 4) Set up systems to ensure social and environmental grievances are managed effectively and transparently.
- 5) Develop and facilitate the implementation of the project ESIA/ESMP based on the ESMF ensuring that UNDP's SES policy is fully met and the reporting requirements are fulfilled.



- 6) Set up a monitoring framework to ensure full disclosure with concerned stakeholders and that environmental and social risks are identified, avoided, mitigated and managed throughout project implementation.
- 7) Work with the project's M&E unit to ensure reporting, monitoring and evaluation, fully address the safeguard issues of the project.
- 8) Monitor project progress and participate in the production of progress reports ensuring that they meet the necessary reporting requirements and standards.
- 9) Develop project-specific M&E tools as necessary and support project site M&E and learning missions and ensure project's M&E meets the requirements of the Government, the UNDP Country Office, and UNDP-GEF.
- 10) Develop illustrated Social and Environmental Safeguards training manuals and technical guidelines for end users and technical guidelines for trainers in English.
- 11) Train project team on UNDP Social and Environmental Safeguards, Grievance Redress Mechanisms, Monitoring, Reporting and Verification, FIPC and Stakeholder Engagement.
- 12) Ensure the implementation of the project's M&E plan, including periodic appraisal of the Project's Theory of Change and Results Framework with reference to actual and potential project progress and results.
- 13) Guide the design of surveys/ assessments commissioned for monitoring and evaluating project results.
- 14) Facilitate mid-term and terminal evaluations of the project, including management responses.
- 15) Review the SESP annually, and update and revise corresponding risk log; mitigation/management plans as necessary.

Required Education, training, license, registration, and certification

- 1) MSc. in the area of Agriculture, Sustainable Land and Environment Management, Climate Change, Natural Resource Management, Water Resources Management or a related discipline
- 2) Well experienced in participatory watershed restoration and application of GIS.

Experience

- 1) A minimum of 5 years' experience in a senior technical lead position with planning and management of social and environmental safeguards including environmental impact assessments;
- 2) A minimum of 5 years in a senior technical position involved in institutional strengthening and capacity building;
- 3) Demonstrated experience of working with climate adaptation planning processes would be an asset;
- 4) Previous similar experience in provision of technical support to complex projects and Global Environment Facility (GEF) financed project will be an added advantage;
- 5) Proven experience in developing consultancy works on social and environmental safeguards.
- 6) At least 5 years' experience in facilitating TOT and subsequent monitoring of TOT participants.
- 7) Must have a vast experience in facilitating climate change adaptation and natural resource management policy.





- 8) Previous experiences in similar assignments, with recorded levels of success is desirable.
- 9) Good understanding of South Sudan social and political context.
- 10) Familiarity with the local economic environment of South Sudan.
- 11) Understanding of Arabic language is a must.

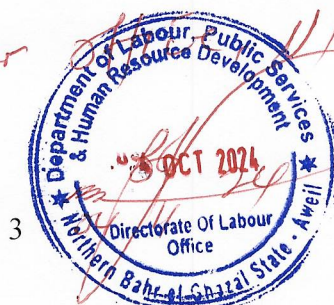
