Purpose of the position:

The consultancy work will start as soon as possible and all the processes and deliverables must be completed **within 40 days** of signing the contractual agreement. The task is very time sensitive, and hence in the work plan the Agricultural/Civil Engineer should present in detail how they will undertake the work in the provided timeframe.

ROLES AND RESPONSIBILITIES:

Project management oversight (work plans, outcomes, outputs Budget, risks and Staff Management are appropriately addressed)

The Agricultural/Civil Engineers will be responsible for the following:

- 1) Provide a detailed Inception Report
- 2) Conduct a participatory resource use mapping of watershed areas and water resource use patterns of settlements in selected sites.
- 3) Undertake comprehensive and participatory surveys to identify sites for: i) water points (shallow boreholes, hafirs, ponds, water yards and Hand pump) and pumping systems; ii) soil and water conservation measures in catchments; iii) flood control structures, wetlands, ponds and channels.
- 4) Undertake an assessment of key challenges to watershed management and resource use and identify root causes, underlying causes and immediate causes.

- 5) Identify measures for addressing the watershed management challenges and propose interventions measures and site-specific plans (which include EIA where needed),
- 6) Prepare a technical report containing site specific plans, designs and drawings of water points and pumping systems with detailed estimates for cost, labor and material estimates for each of the proposed interventions proposed for soil and water conservation.
- 7) Undertake an assessment of Environmental impact assessment of proposed interventions to ensure that they are environmental and biodiversity friendly.
- 8) Ensure participation of relevant user groups during the development of these site-specific plans including Validating technical drawings and plans with the Watershed Committees.
- 9) Develop operation and maintenance plans as well as estimates of related costs and operation and sourcing of relevant materials and parts are built into the technical report.
- 10) Assess rehabilitation needs and develop a rehabilitation plan of existing water harvesting and use systems.
- 11) Provide technical support to the CTA, project staff and communities

Required Education, training, license, registration, and certification

- 1) Minimum qualification in MSc. in the area of Civil Engineering; Water Engineering; Agriculture; Water and Environmental Engineering; Civil and Environmental Engineering, Natural Resource Management or a related discipline
- 2) Well experienced in participatory watershed restoration and application of GIS.

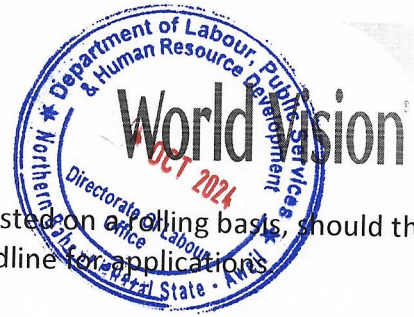
Experience

- 1) Minimum 5 years' experience in in a senior technical lead position in infrastructure works or in Water and/or Sanitation Project implementation. And 3 years' experience in fragile context programming.
- 2) Demonstrated experience of working with climate adaptation planning processes would be an asset;
- 3) Previous similar experience in provision of technical support to complex projects and Global Environment Facility (GEF) financed project will be an added advantage;
- 4) Proven experience in developing consultancy works on catchment restoration and management.
- 5) At least 5 years' experience in facilitating TOT and subsequent monitoring of TOT participants.
- 6) Previous experiences in the similar assignments, with recorded levels of success is desirable.
- 7) Good understanding of South Sudan social and political context.
- 8) Familiarity with the local economic environment of South Sudan.
- 9) Impeccable communication skills, especially with adult learners and semi-illiterate participants
