The organization focuses on Food Security and Livelihoods (FSL), Water, Sanitation and Hygiene (WASH), Gender Based Violence (GBV), General Protection (GP), Health and Nutrition. Coalition for Humanity has experience in integrating projects and forming a nexus across sectors in order to leverage on resources. We consider Protection/GBV, Housing, Land and Property rights (HLP) governance, peace building and conflict transformation as cross cutting issues. We have successfully integrated these in WASH, FSL, Non-food items, Health and Nutrition

CH has its headquarters in Juba, with presence in Leer, Panyijiar, Mayendit, Koch, Mayom and Rubkona counties in Unity State, Maiwut Renk and Longechuk in Upper Nile state. Juba County in Central Equatoria, Ruweng Administrative Area and Aweil West in Northern, Bahr El Ghazal.CH is also presence in Greater Pibor Administrative with physical office in Rochalla County. Purpose

We are a non-profit organization that provides humanitarian and developh for sist and ovulnerable communities in South Sudan. Given the vast geographical spread and limited infrastructure in South Sudan, timely and efficient transportation is essential for CH's operations. To overcome logistical challenges, CH relies on charter flight services to transport Operational equipment's and supplies, medical supplies, food aid, and other essential resources from Juba to field offices and project sites. Reliable air transport ensures uninterrupted service delivery, supports emergency response.

As CH expands its humanitarian reach, the organization seeks to engage a dependable air transport provider capable of offering flexible, safe, and cost-effective charter flight services. This Request for Quotation (RFQ) invites experienced aviation service providers to submit proposals tailored to CH's needs for flights to field locations with payload capacities of 1 metric ton and 2 metric tons.

Scope of Work

CH seeks proposals for charter flight services with the following specifications:

Capacity Requirements:

- 1. Option 1: Aircraft with a payload capacity of **1 metric ton**.
- 2. Option 2: Aircraft with a payload capacity of **2 metric tons**.


2. Service Requirements:

- 1. Flexible scheduling to accommodate CH's operational demands.
- 2. Compliance with South Sudan's aviation and safety regulations.
- 3. Proof of aircraft maintenance and operator licenses.
- 4. Provision of insurance coverage for cargo.

Evaluation Criteria

We will evaluate and compare the Quotations based on the following criteria:

- 1. Service Reliability and Safety Standards (40%)
- 2. Cost-Effectiveness (30%)
