1. Description of the organization and its activities

Malteser International is the international humanitarian relief agency of the Sovereign Order of Malta. For over 60 years we provide relief and recovery for people during and following conflicts and disasters around the world. Christian values and humanitarian principles form the foundations of our work. In over 30 countries in Africa, the Americas, Asia and the Middle East, we support people in need – regardless of their religion, origin or political convictions.

The program is aiming to increase its work with local partner organisations in order to optimise its sustainability. Objective of SOB: In accordance with the overall targets of above-mentioned operations, MI plans to procure and deliver field crop seeds for 2000 households and 100 demo sites during the main rainy season cultivation in 7 Payam's in Western Bahr El Ghazel- Wau.

2. Tenders Presentation

3. General conditions

Evaluation and Award

Evaluation Method

Tenders shall be evaluated according to the following procedure:

Firstly, tenders shall be evaluated for technical compliance based on:

- Technical expertise and implementation methodology,
- Previous experience in similar project and
- Resources and key personnel.

Secondly, tenders that are found to be technically compliant shall be evaluated based on price and value for money, analysing all relevant costs, risks and benefits of each tender throughout the whole life cycle of the works and in the context of the project as a whole. The evaluation shall be in accordance with the provisions of this Reposted SOB and in accordance with the following weighting:

- a. The set criteria shall be used to determine the most economically advantageous tender for contract award,

- b. The Bidder's initial proposal should contain the tender's best terms from a cost or price and technical standpoint,

- d. Bidders are forewarned that an acceptable proposal with the lowest price may not be selected if award to a higher-priced proposal affords MI a greater overall benefit,
- e. The MI will favourably evaluate a schedule, which shows earlier completion than the MI's required time frame. The Bidder's innovative approaches to accomplish early completion are encouraged.
