I. PROJECT INFORMATION

The United Nations World Food Programme (WFP) in Khartoum, Sudan seeks *Expressions of Interest* (EOIs) from contractors or joint ventures able to conduct construction activities in Kauda (South Kordofan N 11.0501°, E 30.5594°) and Yabus (Blue Nile State, N 9.9400°, E 34.1689°). Established companies with verifiable experience in or near these locations are encouraged to complete the attached supplier registration form.

It is anticipated that in 2020-2021 the Procurement Unit of UNWFP Sudan will issue tenders for civil works, electrical wiring, water reticulation, and road rehabilitation, as well as construction of brick masonry housing and offices, a low water crossing, and a suspension cable footbridge in these areas. Eligible contractors or joint ventures who meet the prequalification criteria outlined in this *Request for Expressions of Interest* will be registered with the WFP Sudan Country Office vendor roster and may be invited to participate in upcoming tenders.

II. SPECIAL CONDITIONS

- This *Request* does not contain a contractual offer of any kind. Any application submitted will be regarded solely as an intention to register and participate in WFP procurements, and not as a contractual commitment of any kind on the part of WFP.
- *Terms of Reference, Specifications, Drawings, Bills of Quantities*, and related information specific to each project will be sent to qualified bidders in upcoming *Requests for Proposals* for each project.

III. SUBMISSION REQUIREMENTS

For consideration for pre-qualification, vendors are required to submit the following documents:

1. WFP **Supplier Registration Form** filled in completely, signed, and stamped. Vendors must answer all questions on the attached form for the submission to be considered;
2. **Business / trading license** from the country of registration for the current year;
3. Company profile and associated documents indicating the following:
 - a. The **type of services and works** the company provides;
 - b. Information about the **company structure** including ownership and management;



- c. **CV's of key staff:** project engineer, civil engineer, electrical engineer, water engineer, site supervisor(s), electrician(s), plumber(s), welder(s)
 - d. A **list of equipment** owned by or available to the company including excavator, haul truck(s), pickup truck(s), road grader, vibratory compactor, water bowser, bull dozer, concrete mixer, and concrete vibrator. Vendors may list additional equipment not included in this list.
4. Audited / certified **financial statement** for the last two (2) fiscal years. This shall include income statement, balance sheet, and, if applicable, any notes by the independent auditor. Be assured that this information will be kept confidential;
5. **Letter from the vendor's bank** with letterhead of bank and the following details:
 - a. Bank name and address,
 - b. Account name,
 - c. Currency of the account,
 - d. Account number,
 - e. IBAN code,
 - f. SWIFT code,
 - g. Intermediary bank account details if required.
6. Three (3) **reference letters** from reputable clients to attest timely fulfilment of contracts for similar works. This may include road works, haffir construction, bridge construction, footbridge construction, erection of flat pack offices, electrical and water reticulation (including photovoltaic systems), building construction, concrete construction, and labor-intensive construction;


International companies in joint venture with locally registered construction companies should include the following:

7. **Joint venture or partnership certificate** between the international and the local company;
8. The above legal, financial, and capacity documents for **both parties** in the joint venture.
