MHIND PROJECT:

BBC Media Action is running a Mental Health Integrated Development (MHIND) project in South Sudan aimed at improvement of the mental health status and the psychological resilience among communities – through a combination of radio output and community mobilisation activities. The project entails identification of the underlying factors contributing to discrimination / stigma against people suffering from MNS disorders across the intervention areas; Behaviour Change Communication (BCC) radio campaigns across the targeted areas, through local radio stations and designing behaviour change material to be used by the other project partners during community-based awareness campaigns.





OVERALL PURPOSE OF THE JOB:

The Project Manager will be responsible for working with the Senior Projects Manager (SPM) to oversee the design, delivery, project reporting and partner relationship management of assigned BBC Media Action South Sudan projects. Reporting to the Senior Projects Manager, the post-holder will ensure projects are delivered on time, to budget, in accordance with donor funding agreements and ensuring BBC editorial standards are upheld to have the maximum possible impact with audiences. The post holder will be responsible for taking a leading role in the design of new projects, consulting with other BBC Media Action departments to ensure project activities are oriented to meet objectives and intended outcomes. To achieve this the post holder will also be required to apply their knowledge and experience of development approaches including 'theory of change' and to use project management tools, including logical frameworks.

The post holder will be responsible for ensuring the effective planning and delivery of the Mental Health Project (MHiND) in close coordination with the project consortium implementation Team. The role requires the post holder to utilize BBC Media Action research for learning, monitoring and improving how we design and deliver projects as well as secure new funding.

Main Duties:

- Responsible for overall planning and management of the project
- Will be responsible for overall production of radio Programmer's content and broadcast and will work closely with the Production team to ensure the radio broadcast are on air.
- Coordinate the development of technical support materials including visual story telling materials in collaboration with technical partners.
- Monitor project outputs and ensure all activities are completed in a timely and efficient manner
- Compile, maintain, and document the projects related reports, daily work records and other relevant documents.
- Submit the required reports and other requirements in line with the approved deadlines and formats by the donor
- Responsible for budget forecast planning and project spending control and participate in reviews of Project Financial Reports in coordination with Finance department.
- Work closely with the Research and Learning team to feed into the design of research activities including formative research as well as quantitative and qualitative monitoring and evaluation research.
- Draft and produce donor and internal reports on projects progress using impact and lesson learning data with oversight from the Snr Project Manager.
- With oversight from the Snr Project Manager develop and manage effective relationships with project partners, donor agencies, stakeholders, and other consortium partners



- Work closely with London thematic teams to develop and maintain in-country expertise of the role of media and communication governance, health, and resilience work in South Sudan.
- Will participate in business development related activities.
- A team Leader and Line management of allocated staff in the department

- Ability to organize work, lead and deliver activities with high level standards, and proven track record in producing quality work.
