#### BACKGROUND

IntraHealth International, Inc is a US based, global health nonprofit organization that has worked for 40 years in over 100 countries including South Sudan. Currently, IntraHealth is implementing several projects in South Sudan with funding from US Centers for Diseases Control and Prevention (CDC) and USAID in collaboration with Government of South Sudan Ministry of Health (MOH) and South Sudan AIDS Commission. Our mission is to improve the performance of health workers and strengthen the systems in which they work so that everyone everywhere has the health care they need to thrive. IntraHealth's programs generate long term social and economic impact to keep communities around the world healthy, strong and prosperous. And our dynamic staff are passionate about global health and committed to excellence.

## PROJECT DESCRIPTION AND SUMMARY OF ROLE

Advancing HIV & AIDS Epidemic Control (AHEC) Activity is a USAID funded consortium led by IntraHealth to create a rapid community-led response and aggressively strengthen HIV services along the prevention-to-care continuum, paying special attention to case finding and retention. AHEC will build or improve effective networks of care through KP-focused community services in identified regions of South Sudan.

The PrEP Clinical Officer will be responsible to facilitate the training of service providers, initiate the pilot of PrEP in selected sites, and document lessons learnt to facilitate the national roll-out. S/he will work with the ART nurses, COVs, PEs, and PNs for demand creation among segments of the population identified as having a high on-going risk including discordant couples, KP among others.\_Improve the quality of HIV care and treatment at the facility. He/she will ensure that services adhere to PEPFAR and Ministry of Health technical standards.

#### **ESSENTIAL FUNCTIONS**

- Provide full time clinical evaluation and treatment services to clients at potential high risk of HIV infection
- Conduct training for service providers on PrEP for quality service delivery.
- Provide oversight role and supervision to the team of nurses and Peer educators linked to the community network for quality PrEP service delivery
- Establish community facility link for appropriate mobilization, referral, and tracing of clients for access of PrEP services
- Support in Identification of clients at substantial risk of HIV for PrEP initiation
- Ensure HIV testing services is conducted to clients at substantial risk and if negative a course of PrEP along with condoms and water-based lubricants is provided
- Support and document follow up of clients initiated on PrEP to determine PrEP retention outcome
- Engage key players to generate demand for PrEP and ensure high levels of adherence
- Integrate PrEP delivery into existing community-based outreach services
- Collect data essential for monitoring adverse events, other outcomes like seroconversion after the person has been initiated on ART
- Document and monitor related tests at regular intervals such that PrEP is used in safe and effective manner.
- Manage and follow the supply chain management for PrEP commodities
- Responsible for providing updates and discussing progress on PrEP implementation to project staff
