1. PROJECT BACKGROUND

AMALNA South Sudan is a non-partisan and non-profit national organization registered by the Relief and Rehabilitation Commission (RRC) in November 2016. The main aim of establishing the organization is to work with local communities at the grassroots level through the provision of edutainment, information, and communication tools that empowers and strengthen youth, women, children, and the citizenry to build a peaceful South Sudan. AMSS is experienced in the use of communication and dialogue to inspire 'positive voices' as a means of promoting a culture of peace and reconciliation that contributes to reconciliation in communities by supporting inclusive community engagements and awareness-raising through the use of drama, street theatre, outreach activities, radio, art, music, culture, and capacity-building targeting mainly the youth, children, community leaders, and women.

AMALNA South Sudan is implementing a consortium project "Picturing a Common Future (PCF)" in Collaboration with PAX and the Mobile Cinema Foundation supported by the Norwegian Ministry of Foreign Affairs. Picturing a common future uses the methodology of film screenings to galvanize South Sudanese youth between 18-35 years of age to undertake reconciliatory initiatives to promote peaceful coexistence at the community level.

A multi-layered strategic approach been used with mobile cinema for dialogue, as a means to mobilizing youth to engage in reconciliatory actions. By sharing current and past grievances, and engaging in further dialogue and reconciliation. Mobile Cinema screening events, youth engagements, capacity building on reconciliation and forgiveness helped raise awareness of positive and inspiring examples of how ethnically diverse individuals and youth groups can initiate conciliatory actions and become a non-violent actor of peace.

2. OVERVIEW OF THE COMMUNITY DIALOGUE FORUM CONSULTANCY

Amalna and the PCF project, through the use of mobile cinema film screening, community engagement on reconciliation, and support to youth group reconciliation initiatives have encouraged a people-to-people peacebuilding engagement, and supporting youth in making decisions and initiating actions to build connection and cohesion. In line with this, the aim of the dialogue forum consultancy is, therefore: first, to look through the previous content/materials, reports and identify key issues relating to social cohesion between communities and develop an inclusive interactive tool to facilitate dialogue forum?

3. TERMS FOR CONSULTANT

The community dialogue forum consultancy covers the three areas of Bor, Juba and Rumbek for at least a maximum of 30 participants per each location for two days. The number of days for the dialogue forums are two (02) days per location

AMALNA seeks the services of a consultant who is in charge in the realization of the completion of the community dialogue forums of 02 days per location making a total of six days, for the forums in these locations two days each of report writing and two days each for travel and preparation

Service 1: The Dialogue forum program Design: Technical proposal including a methodology on how to approach and complete the assignment.

- a) Develop a facilitation tool and guide for the realization of the objectives of the forum by reviewing screening reports, coaching reports, other sources of relevant information, and the project proposal document.
- b) Design two sets of community dialogue forums one at the state level (Bor and Rumbek) and the other at the national level (Juba) with inputs from the state level and other sources.
- c) Facilitate the community dialogue forums in the three locations, compile three different reports per the locations and one general report of the dialogue forums.
- d) In collaboration with AMALNA staff arrange schedules of the dialogue forums with the target participants of the three locations.
- e) Review project documents and reports from previous screening
- f) Identifies key issues that came out of the discussions and develop training/workshop materials targeting policymakers, youth leaders, CSOs, etc that are based on the previous issues raised from the screenings.
- g) Facilitate 2 community peace dialogues in Bor and Rumbek that will inform the final national community peace dialogue in Juba.
 - Write and submit 3 activity report and one consolidated report for all the 3 dialogue discussions.

Service 2: Actual conduct and facilitation of the dialogue forums: Conduct and facilitate the three (3) community dialogue forums in Bor, Rumbek and summarized with Juba forum.

Expected Outputs

- a) Outputs related to service 1: Produced two (2) designs of the dialogue forums for the state-level dialogue and the national-level dialogue.

 - Specific Objectives

 - Book flights and facilitates the travel of the consultant to the field and back to Juba.
 - Validate the reports of the dialogue facilitation, and all the outputs in general.
 - Provides stationery and the use of projector in any case the identified venue cannot provide.
 - Unveils all required documents for review by the consultant and provides the consultant with office space where necessary.
 - Transportation: Arrange transportation and reimbursements of training participants.
 - Provide meals for the participants during the dialogue forums
