2. Qualification Requirement Includes:

- a. Eligibility: the bidder must provide company legal documents e.g. Certificate of incorporation, Tax clearance, TIN/PIN, Trade license, company profile, tax clearance certificate, import license, Drilling license and other legal registration documents.
- b. Financial Capability: The bidder must demonstrate access to or availability of financial resources such as liquid assets (funds- bank statements), lines of credit, and other financial means (fixed and real assets not considered here).
- c. Experience: the bidder must provide evidence of participating as a main supplier in at least five (5) contracts within the last five (5) years, similar to the proposed supply.
- d. **Delivery:** The Goods covered by this bidding process are required to be delivered in accordance with, and completed within, the Delivery and Completion Schedule specified in the bidding document.
- 3. Bidding will be in accordance with the National Competitive Bidding procedures.
- **4.** Bids shall be valid for a bid period of **90 days** after Bid Opening. Bids with less validity period will be rejected.
- 5. Interested bidders may obtain further information or clarification from UNKEA South Sudan Attention Chairman, Tender Committee through mariaka@unkea.org, from 09.00 to 16.00 hours at the address given below (Monday to Friday).
- **6.** Bids received through email shall be rejected
- 7. Bids received after the deadline shall NOT be considered
- **8.** All the bidders are advised to register at the gate with security (on the Bid registration list) before dropping the bid in the tender box. Unregistered bids shall not be considered

9. All bidders' representatives are advised to drop their bids personally in the tender box.
