### Job Descriptions

Some specific responsibilities include:

- Oversee and supervise the finance for CIDA in south Sudan, ensuring accurate, timely
  accounting and reporting and adherence to organizational policies and procedures.
- Be responsible for al! project accounting and donor reporting.
- Maintain financial records including ledger, journals, petty cash, intercompany and bank details.
- Prepare financial reports including donor and monthly management accounts
- Prepare in conjunction with the executive director, the monthly project pipeline forecast.
- Leads on cash flow management.
- Leads on the monitoring and mitigation of financial risk.
- Manage donor's audits and other inspections of the finance function.
