## KEY RESPONSIBILITIES

The M&E Officer will perform the following duties and report to the Head of Programs based in the Juba Office.

- Develop and implement a robust monitoring and evaluation system that will ensure tracking of project/program results at different levels (outputs, outcomes, and impact).
- b. Develop/ adopt an integrated database of all State/ County projects/programs and ensure accountability through regular data updates, data integrity, and working in collaboration with the data processors.
- c. Work with program officers and managers to ensure the collection of relevant and appropriate data needed for an effective MEAL system which will be utilized in monitoring strengths, weaknesses, and gaps in existing projects/ programs and services and for reporting on donor commitments.
- d. Incorporate field and technical team feedback to ensure the continuous improvement of data management systems within CIDO South Sudan.
- e. Timely update and share data on the 5/4W matrix to the cluster management system

## Monitoring and Reporting

- f. Develop M&E plans for all projects and proposals and ensure the same is followed up during implementation;
- g. Ensure all grants have updated work plans and performance management plans (PMPs) in tandem with all approved proposals, regularly reviewing and updating as needed
- Carry out data quality assessments/ audits regularly for MEAL data based on agreed indicators to guide decision-making
- Provide alerts to the respective program officers/ managers, HoP, and ED on corrective actions required to avoid delays in implementation, including flagging operational issues and risks requiring timely actions.
- j. Review monthly progress reports from partners and ensure they have evidence to back- up and provide feedback to the respective staff
- Collate/ prepare regional reports related to internal reporting such as the quarterly and annual reports
