### INTRODUCTION:

ACROSS is an interdenominational church base organization which strives to provide humanitarian assistance including emergency/relief, rehabilitation and development work) to local communities, internal displaced persons, refugees and other vulnerable communities to enable them to realize their purpose and value as human beings. ACROSS in South Sudan is looking for competent and qualified South Sudanese national for the position of Midwife.

## Main Job Purpose:

Under the supervision of the Health Officer and the support of the Clinical Officer, the midwife is expected to ensure provision of comprehensive safe motherhood services through antenatal, natal and post-natal care services. And provision of family planning services, PMTCT services and VCT service to Persons of Concern (POC) in Gorom refugee settlement.

#### JOB FUNCTIONS:

- Overall, in-charge of the daily administrative and technical functions at the maternity unit.
- Provide professional medical care to the highest quality and in accordance with national and international laws, protocols, and standards (Antenatal care, Normal deliveries, assisted deliveries, postnatal care, post abortion care.
- Ensure high quality of patient care by conducting regular quality of care assessments of the maternity unit and implementing recommendations thereof.
- Timely identification and referral for of cases of complicated and high risks pregnancy.
- Follow-up patients as appropriate including those referred to higher facilities.



- Provides Family planning methods "oral, injectable, implants" to intended persons of concern.
- Effective referral of clients wishing to undertake permanent methods such as tubal ligation (TL) and vasectomy to pre-determined points.
- Conduct relevant individual and group health education session.
- Updating patients' registration books, maintaining and reviewing patient records, charts and other pertinent information relating to HIS.
- Advice patients and community members concerning Ante Natal Care, Post Natal Care, Breast feeding, Family Planning and other Sexual and Reproductive Health topics.
- Prepare monthly work/activity plans for him/herself for review by the Supervisor.
- Perform tasks as needed by the direct supervisor that are relevant to the position.
- Report needs, concerns, and achievements in the field to the direct supervisor, Data management and reporting, weekly, monthly reports.
- Plan and provide on-job training and mentorship to the MCHWs.
- Ensure that the birth Registration of babies is carried out, list compiled and submitted to UNHCR monthly.
- Monitor and supervise the promotion of IYCF practices in the unit
- Ensure SOPs and guidelines are strictly adhered to.
- Ensure high quality programming at the maternity unit with mainstreaming of the principles of protection (safe programming), disaster risk reduction and environmental awareness activities.

 Bachelor degree in Midwifery or Clinical Medicine with valid practice license from South Sudan Medical Council.
