## **Main Purpose**

Supervising the daily logistics activities and providing maintenance to the MSF equipment, facilities and infrastructures, according to MSF standards and protocols in order to maintain the facilities in perfect conditions and collaborate in the development of the mission..

## Main Duties & Responsibilities

- Monitoring maintenance activities of infrastructures, management of non-medical stocks and equipment according to MSF standards
- Ensuring the check and follow-up of facilities under the line manager's supervision through
  daily visits to the facilities and reporting any anomalies or problems, evaluation of the
  rehabilitation needs and following up minor building rehabilitation work according to
  supervisor's instructions; checking that premises observe security norms and monitoring
  the consumption of mechanical and electrical vehicles/machines/devices
- Coordinating and leading the logistics team under his/her responsibility which includes daily supervision, monitoring of the quality of work and the definition of each person's task, drawing up their working schedules; organizing and leading team meetings; participating in the recruitment of team personnel and attending logistics meetings and accounting for his activities
- Ensuring the vehicle fleet maintenance which includes planning and overseeing timely
  preventive and curative maintenance of all project Boats according to MSF standards and
  instructing and monitoring drivers on correct driving habits and standard checks
- Managing and following up orders which includes collecting logistics orders coming from different departments or health facilities; drawing up and following up orders according to

the procedures in force; providing technical support to the storekeeper, makes local purchases according to MSF supply procedures and ensures reception conditions of freight or arriving material as well as the organization and setting up of materials before its shipment

- Covering the gap in absent of Log base / Hospital according to MSF management procedures.
- Supporting DMC team and maintaining the Facility site and report abnormal condition during the boat's movements.

# MSF SPECIFIC ACCOUNTABILITIES

- Responsible for arrangement of all movements (DMC, referrals etc.)
- Responsible for fueling of boats and keep records.
- Maintenance follow-up of all boats.
- Prepare movement sheets and mission orders before any movements
- Follow up the maintenance of all the boat engines and regularly checking
- Coordinating with the Flying Mechanic for issue of boat engine
- All the Checklist items to be checked for the movement by boat and update regularly
- All materials in check list to be ready for movement daily for the DMC & Kiss movement
- Giving Log Support for all DMC Sites and Kiss Movement
- Regularly meeting with the boat drivers and resolve the issues
- Preparing rooster for boat driver monthly
- Preparation and follow-up of roadbooks, including time-keeping support to Radio Operator
   + GPS tracking of all the communities and stopping points downstream and upstream.
- With the support from Watsan Supervisor and Watsan Manager, evaluate the needs of WASH in DMC sites and constant checking on IPC/WatSan materials in DMC sites.
- Support to other logistic activities to cover possible gaps of Log Supervisors in Ulang Hospital or Base.
