# Background

Charity and Empowerment Foundation (CEF) is a local national and not for profit organization established in 2017 to address the most urgent and pressing needs of the people of South Sudan. The aim of forming CEF is to lead positive social change by empowering communities to improve their healthy living conditions, fight poverty, illiteracy, marginalization, injustice, dictatorship, and traditional institutions that oppress and discriminate women. By following its mission, CEF launched the implementation of the project "Enhancing Emergency Food Production for People Affected by Severe Food Crisis in Central Equatoria —Mangala Payam" with the funding from Mastercard Foundation — a scholars' program in Wellesley University, College of Entrepreneurships, Massachusetts, USA, Bolton. This fund will be used to empower low-income subsistence farmers in South Sudan through provision of treadle irrigation pumps, farming tools and seeds to improve their living standard.

## **Duties/Assignments:**

The FSL Extension worker (An Intern) will:

 Participate and contribute in all the assessments, planning, development, implementation, training, monitoring and evaluation of activities that are related to FSL programming in Mangalla.



- Provide timely updates on the overall food security and livelihoods situation in the Mangalla area; This especially for the host Livelihoods, agricultural and agricultural products markets and trade, Crops disease surveillance, Status of Farms, access to crop prevention services.
- Provide support in developing new proposals, providing data, information on: beneficiary expressed needs, context information, local authorities' policies and plans, coordination with existing actors in the agricultural sector, markets and functionality.
- Organize and conduct awareness creation to beneficiaries on preventive measures of COVID-19, PSEA, conflict resolutions.
- Support identification, registration and verification of beneficiaries who will receive the seeds and treadle irrigation tools. /Referral of families/individuals/children at high risk for food, livelihood for other essential support.
- Support dissemination of protection and COVID-19 messaging at, Churches, Mosques, Markets, water points & during clinics visitation.
- Ensures that FSL indicators are achieved in the FSL initiatives implementation.
- Promote and implement effective measures to identify, prevent and reduce force marriage, child marriage, and violence against children.
- Promote International and National Law and applicable CEF standards and ensure that all activities of CEF fulfil protection mainstreaming responsibilities.
- Responsible for the resolution of issues that may arise among the farmers among other community stakeholders. Contribute to timely, accurate and appropriate report of extension activities in the Payam of work.

Plan, implement and monitor Food Security and Livelihood (FSL) interventions in the Livelihood sector in case of emergency response.

- Produce regular activity progress reports to the team leader/PM providing complete data on achievements against planned outputs (locations, beneficiaries reached, meeting held, minutes, attendance lists, beneficiary lists, agricultural treatments records, etc.
- Attend FSL cluster meetings and related sub-clusters meetings on behave of CEF
- Other duties as assigned.
