Purpose of the position:

The core responsibilities of this position are to take the lead in overall project management which includes facilitating project implementation, monitoring and reporting of GREAN Project which is operational in Juba County five payams. It is a five-year project from 2019/20 to 2024/25, so far the project completed the fourth year of implementation and remains with one year to contribute to its goal which aligns with the Australian aid investment plan for Sub-Saharan Africa which is to assist African people to achieve more equitable access to the benefits of economic growth and to save lives through appropriate and effective humanitarian action. The project already secured a second phase and will continue until 2028. With its focus on promoting inclusive improved agricultural production for both subsistence and marketing purposes, the project contributes to Objective 2 of DFAT's Aid Invest Plan, which is to enhance agriculture's contribution to sustainable and inclusive economic growth and food security.
