



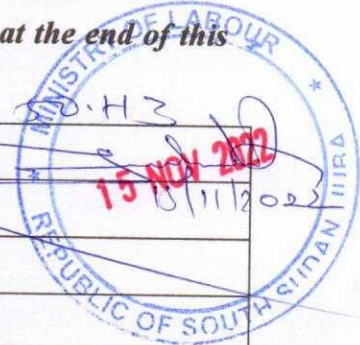

Organizational Background

International Medical Corps is a global, humanitarian, nonprofit organization dedicated to saving lives and relieving suffering through health care training and relief and development programs. Established in 1984 by volunteer doctors and nurses, International Medical Corps is a private, voluntary, nonpolitical, nonsectarian organization. Its mission is to improve the quality of life through health interventions and related activities that build local capacity in underserved communities worldwide. By offering training and health care to local populations and medical assistance to people at highest risk, and with the flexibility to respond rapidly to emergency situations, International Medical Corps rehabilitates devastated health care systems and helps bring them back to self-reliance.

Essential Job duties / Scope of Work:

- ❖ Assist the Mental Health and Psychosocial Support Specialist / Medical Coordinator with the integration of mental health and psychosocial support into general health care



- ❖ Provide and strengthen psychosocial support services linked to general health care clinics
- ❖ Select, provide training, and supervise community outreach volunteers in each refugee camp
- ❖ Develop culturally appropriate psychosocial activities, including social support activities targeting refugees. These include but are not limited to training in psychological first aid, designing holistic recreational, vocational, and social activities; development of material for awareness campaigns.
- ❖ Serve as a point of contact between IMC and local partners involved in mental health and psychosocial support activities under the guidance of the MHPSS specialist
- ❖ Strengthen community-facility referral system for persons with mental health and psychosocial problems.
- ❖ Work in keeping with IASC guidelines on mental health and psychosocial support and promote guidelines where appropriate
- ❖ Work closely with other mental health and psychosocial staff to ensure coordinated activities
- ❖ Collaborate with informal service providers such as natural healers to facilitate information sharing and referral of mental health cases
- ❖ Collaborate with community and existing institutional structures to ensure protection of those suffering from mental illness
- ❖ Compile information and prepare written reports as necessary
- ❖ Organize and participate in public awareness and de-stigmatization campaigns around mental health issues with support from local staff-
- ❖ Actively promote PSEA (Prevention of Sexual Exploitation and Abuse) standards within International Medical Corps and amongst beneficiaries served by International Medical Corps
- ❖ Represent IMC in coordination meetings when assigned to do so by the MHPSS specialist
- ❖ Implement other activities as per the direction of the mental health specialist or psychiatrist managing the MHPSS project
- ❖ The incumbent will be assigned to do other additional activities as assigned or directed by the supervisor

Prevention of Sexual Exploitation and Abuse

- Actively promote PSEA (Prevention of Sexual Exploitation and Abuse) standards within IMC and amongst, vendors-suppliers and beneficiaries served by IMC.

Compliance & Ethics: Promotes and encourages a culture of compliance and ethics throughout International Medical Corps. As applicable to the position, maintains a clear understanding of International Medical Corps' and donor compliance and ethics



standards and adheres to those standards. Conducts work with the highest level of integrity.

Ethical conduct for IMC staffs: The International Medical Corps maintains a code of standards of conduct that shall govern the performances of its employees engaged in the award and administration of contracts. No employee, officer, or agent shall participate in the selection, award, or administration of a contract supported/ by donor funds if a real or apparent conflict of interest would be involved. Such a conflict would arise when the employee, officer, or agent, any member of his or her immediate family, his or her partner, or an organization which employs or about to employ any of the parties indicated above, has a financial or other interest in the firm selected for an award. IMC officers, employees, or agents shall neither solicit nor accept gratuities, favors, or anything of monetary value from contractors, or parties to sub-agreement. These standards shall provide for disciplinary actions to be applied for violations of such standards by IMC officers, employees, or agents.

- ❖ **Diploma /Certificate in Psychiatric/Mental Health Nursing, Diploma in clinical medicine** from a recognized institution.
- ❖ **Registered Nursing**
- ❖ **Two years' experience** in the related **MHPSS activities** with INGO is an added advantage
- ❖ **Strong knowledge of mental health** is an added advantage, including public health
- ❖ Good experience and knowledge of MHPSS related topics such as **mhGAP-HIG and PFA.**
- ❖ **Training and capacity building skills on MHPSS related topics including mhGAP-HIG and PFA** is a plus
- ❖ Possess good **supervision skills**
- ❖ Able to work on multiple tasks and in difficult situations and meet deadlines.
- ❖ Ability to communicate well (including writing) in **English/Arabic/ local language is required.**
