#### Role Description

This position will contribute to better monitoring of CMMB's child protection project implementation in Western Equatoria. The post hold will develop and implement effective monitoring and evaluations system for CMMB to support feedback and organizational learning. The incumbent will be responsible for data collection and analysis, routine monitoring and reporting including learning activities to help ensure accountability and efficiency for CMMB's projects.

This position will be based in Yambio with frequent travels to Nzara and Ezo.

## Main Roles and Responsibilities

- Provides support in the project cycle for quality implementation which includes: Contribution to setting
  realistic and measurable indicators for project proposals, Collecting and analyzing data against the set
  indicators, providing advice on improving project performance, Conducting internal evaluations mid-term
  and after project completion
- He/she develops a MEAL plan, develops relevant tools and techniques to monitor Child Protection projects and supports the projects teams in their implementation ensuring that they are duly filled with reliable information.
- Works with field staff to improve data collection and monitoring processes, including capacity building.

- Conduct regular field monitoring visits to various locations, organize technical follow up meetings, draft field visits reports, suggest the necessary improvements including relevant M&E training and monitor its translation into reality.
- He/she consolidates data from the field in order to produce evidence-based, analytical and quality internal and donor reports within the deadlines; He/she ensures that data is transmitted on time from the field to the coordination office.
- He/she has a leading role in Child Protection needs assessments in various areas: drafting ToRs, draft questionnaires and take a lead in data collection, consolidating quantitative & qualitative data, writing assessment/survey reports etc.
- Supervise the development and management of a Child Protection database management system.
- Develop quality control systems and mechanisms needed to guarantee proper management of information and data. Supervise data protection procedures and filing.
- Under the technical supervision of the Strategic Information Management Manager, develops tools for systematic data collection and analysis.
- Closely collaborate with the Deputy Child Protection Project Manager, PSS Technical Officer, FTR Information management Officer, GBV Officer and Case Management Officer to ensure that M&E tools incorporate inputs from their respective technical fields of expertise.
- Ensure regular communication with the Child Protection Project Manager about updates, achievements and challenges through meetings, reports and ad hoc communication upon request and upcoming needs.
- Coordinate with other CP actors on the ground to effectively contribute to the service mapping exercise, establishment of well-functional CP referral pathways, and information sharing.
- Represent CMMB CP project in fora and meetings held at location or state level in her/his field of expertise, including sharing of information and reporting.
- Contribute to development of a community network to facilitate the project acceptance and stake holder's contribution and ownership.
- Promote, and ensure project activities are in line with child protection principles and humanitarian principles.
- Ensure CMMB Child Safeguarding Policy and Child Protection Minimum Standards are mainstreamed through all the projects activities.
- Report serious cases of abuse committed against children to the Child Protection Project Manager. Strict confidentiality must be respected.
- Document lessons learnt, best practices and participate in the preparation of weekly, monthly and annual reports.
- Uphold high level integrity which represents CMMB
- Deliver any other tasks as assigned by the Child Protection Project Manager
