## 1. Description of the organization and its activities

Help Restore Youth (HeRY) is a national Non-Governmental Organization, has more than 10 years of experience in humanitarian relief and resilience. It covers around 4 projects in NBeG and Juba, annually worth USD1.2m. It provides aid in parts of South Sudan without discrimination i.e. Religion, race, or political affiliation to the most vulnerable population. Christian values and the humanitarian principles and standards guide our work. We envision a harmonious, prosperous, and resilient South Sudan where young people live productively happy. #### 12.Tenders' evaluation

The criteria applied for the evaluation will be the legal conformity, the price, the technical experiences, the compliance with technical specifications and quality standards, and the capacity to deliver, delivery time and meet timeframes as specified. The work will be awarded to the winning bidder according to the timetable mentioned above.
