Although the successful bidder(s) will become the service provider(s), this FARFQ will not constitute an exclusive Framework Agreement and, in the event, that the service provider cannot meet the stipulated lead time or specification then another service provider shall be sought by Medair for that particular purchase.

Medair reserves the right to enter into Framework Agreements with more than one service provider or reject all applicants.

This FARFQ has been issued for the sole purpose of obtaining offers for Trucking services against the specification contained within this document. This is not an offer or commitment from MEDAIR to procure, but outlines conditions to simplify the ordering process. Medair reserves the right not to enter into or award a Framework Agreement as a result of this FARFQ.

The Bidders will not be entitled to claim from Medair any costs or expenses which may be incurred in preparing and / or submitting the tender. This condition applies irrespective of the success of the Quotation. It also applies to any additional cost that may incur as part of this competition should Medair modify or amend the FARFQ requirements or the service design.

Any attempt by the Bidder to obtain confidential information, enter into unlawful agreements with competitors or influence the evaluation committee or Medair during the process of examining, clarifying, evaluating and comparing Quotations will lead to the rejection of its offers and may result in the termination of Framework Agreement where applicable.

Medair reserves the right to reject any Quotation or to terminate the Framework Agreement, if it is determined that the Service Provider is engaged in corrupt, fraudulent, collusive or coercive practices.

Medair shall NOT be bound to accept the lowest priced or any Quotation, and reserves the power to accept any part of any Quotation, unless the Bidder expressly stipulates to the contrary at the time of Quotation submission.

If there is any conflict, it is a fundamental term of the FARFQ that the Bidder acknowledges and accepts that the terms and conditions of Medair shall prevail.
