PURPOSE OF POSITION:

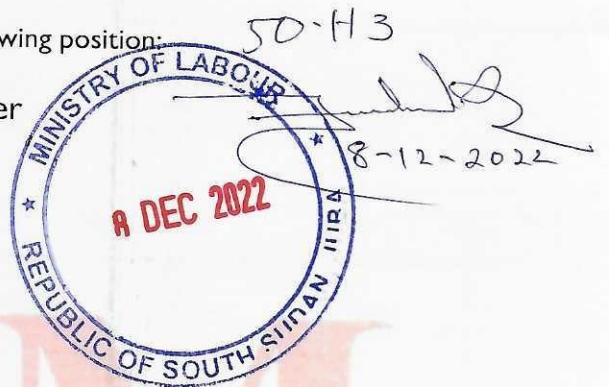
The Field Level Food Security and Livelihoods (FSL) officer is responsible for managing all agriculture, food security and livelihoods activities of JAM in the assigned location. He/she will be responsible for coordinating and technical leading the direct implementation of FSL activities including the provision of technical support and training to his/her subordinates, local governments and the targeted community. He/she will work closely with program coordinator, Area manager and other colleagues to ensure that activities are timely implemented, monitored and reported according to agreed project plan, in line with the donor requirements and JAM policies.

KEY RESPONSIBILITIES:

Project Implementation and sustainability

- Implements activities as described in the project proposal based on JAM policy
- Take lead in project implementation and monitoring of progress in line with donor requirements.
- Responsible for financial expenditure monitoring and related cost allocations, on the basis of approved project budgets.
- Technically supporting and supervision subordinates in the field FSL team.
- Maintaining effective coordination and working relations with donors and other relevant stakeholders at field level

Community engagement and advocacy



- Take overall lead in the coordination of field livelihood level activities
- Develop farmer's capacity to improve production and productivity
- Mobilize and facilitate the engagements of stakeholders during planning and development meetings, workshops and other fora.
- Coordinate partners in implementation of agreed action plans.
- Ensure integration of project with other ongoing FSL activities in the project location.

Stakeholders Engagement, Networking and Collaboration

- Engagement with key stakeholders for influence and learning
- Actively represent JAM in FSL Cluster coordination together with Area Manager.
- Engage and build relationships with key partners and government counterparts.
- Network and collaborate with Local Government and relevant stakeholders in the Program Area.

Documentation, Reporting and knowledge management

- Writes and submits monthly and quarterly progress reports, and specific activity reports, and any other reports when necessary to supervisor in a timely manner.
- Reporting - monthly and quarterly financial reporting, including realization of activities versus budget utilization; (Providing input to) narrative and financial programme reporting;
- Take lead in documentation and sharing of success/case stories and best practices to promote learning.
- Organize review meetings for partners and communities at the project sites to reflect on project approaches, tools, impact of interventions, best practices, exit and sustainability strategies as well as create spaces and opportunities for action-learning.

- At least Diploma in Agriculture or any other relevant discipline
- Minimum of 4-year professional work experience in implementing food security and Livelihoods activities at field level in particular in the areas of crop, vegetable and fishery productions.
- Good Project Management, Budgeting and Monitoring and Evaluation experience
- Good spoken and written command of English. Knowledge of Arabic or the local language of the project site is an added advantage.
- Good communication, facilitation and networking skills in particular with local community;
- Knowledge of the local context is an added advantage;
- Track record demonstrating high integrity, innovativeness, creativity, reliability and dependable
- Good computer application skills in Microsoft packages (Word, Excel and PowerPoint);
- Team player, Self-motivator, able to work with limited supervision
