Job Summary:

The Enhanced Adherence Counselor (EAC Focal Person) will lead activities to improve viral load suppression (VLS) among children, adolescents, and adults on ART through targeted enhanced adherence counseling (EAC) and follow-up of high viral load (HVL) clients. Working closely with the ART Clinician, VL Focal Person, and community teams, the role ensures timely receipt and action on VL results, conducts structured counseling sessions, supports repeat VL sample collection, and coordinates multidisciplinary team (MDT) discussions for persistent HVL clients. The EAC Focal Person promotes client-centered counseling, improved treatment literacy, and strong linkage between clinical and community support systems to sustain virologic suppression.

Key Responsibilities and Tasks:

- Provide individualized EAC sessions for clients with HVL or sub-optimal adherence.
- Ensure prompt documentation of HVL results and initiate repeat VL testing per SOPs.
- Maintain updated HVL registers and Rapid Recovery (RR) tracking tools.
- Coordinate MDT meetings to review persistent HVL cases and follow-up management plans.
- Conduct daily health education sessions in ART waiting areas.
- Collaborate with VL and community teams to ensure linkage, follow-up, and reporting.
- Support integration of adherence, index testing, and EID services for holistic care.
