## Context of the position and key challenges

This advertised position is based in YEI within the Greater Equatoria Area. Under the supervision of the FSL Project Officer (PO), the Field Extension Worker is responsible for ensuring proper implementation of ACTED's FSL project in the field. The project is implemented in partnership with GIZ. The Extension Worker implements field operations and ensures effective and timely completion of activities, delivery of quality outputs and achievement of outcomes with maximum impact for beneficiaries. He/she will support the FSL Project Officer in imparting skills and knowledge to communities in best farming method/practices through trainings and result-based experiments in order to improve food production and household income of targeted project beneficiaries (agro-pastoral communities). She/he will be fully responsible for quality-of-service delivery and respect of the targets.

# Key roles and responsibilities

# Project Implementation

- Works closely with the FSL PO to plan and implement day-to-day project activities and submits regular reports as required by the PO
- Develops training materiasl and provides training/capacity building to agricultural advisory and farmers groups, with a focus on sustainable farming practices
- Participates in the distribution of agricultural inputs such as tools, seeds and others items to farmer groups at the project site
- Collects, analyzes and evaluates agricultural data and supports developing techniques assisting farmers to enhance sustainable farming practices, including practical demonstration
- Facilitates farmer group formation in close coordination with community leaders
- Organizes and conducts cooperative extension program to advise and instruct farmers engaged in agri-business in applications of agricultural research findings
- Supports PO and AME team with community mobilization and beneficiaries' selection
- · Contributes to assessments, monitoring and evaluation activities, in coordination with AME team
- Assists FSL PO in planning activities and maintaining program records
- Maintains positive relationships with key stakeholders, such as local authorities, agriculture institutions, bomas and payams community leaders
- Performs any other duty as it may be assigned by the supervisor

- Supports accurate filing and archiving of project documentation

- Assists the PO in monitoring project performance against AME indicators, contributing to addressing performance issues in a timely manner
- Assists the PO in the dissemination of the findings and results of surveys and ongoing analysis both within ACTED and with relevant stakeholders
- Contributes to regular monitoring activities, as indicated by the AME team

## Required qualifications and technical expertise

- O Diploma or bachelor degree in in Agriculture Extension, Food Security and Livelihood, Community and Rural Development, or other related social science degree.
- A minimum of 2 years of relevant working experience with an NGO/INGO in food security, livelihood, agriculture or resilience programming
- o Good understanding and experience with livelihoods concepts and sustainable farming practices in a resilience context with proven experience in conducting trainings and capacity building on related topics
- o Excellent interpersonal, communication and presentation skills
- Fluency in written and spoken English, with ability to communicate in local languages; ability to communicate in Arabic is considered an advantage
- o Commitment to and understanding of ACTED's aims, values and principles, including rights-based approaches and do no harm
- Experience in partnership building and coordination with external stakeholders (including donors, partners, local authorities, community leaders and beneficiaries)
- Experience with Microsoft Office (Word, Excel, Power Point and Outlook)
- Ability to work independently and as part of a team
