A copy of this tender document can be collected at the same locations.

# Bidding will be conducted through an open tender procedure.

- The tender is for FCA field office in Yei, Central Equatorial State.
- All other costs for regular service and maintenance, fuel, repairs and drivers salary shall remain the responsibility of the successful bidder.

### **Minimum Requirements**

Submission of tenders should include valid company registration and operation documents below:

- Certificate of Incorporation from the Ministry of Justice including the renewal stamps at the back of the certificate.
- Membership Certificate from the Ministry of Chambers
- Tax Identification Certificate
- Tax Clearance Certificate
- Operation Licence from the State Ministry of Finance & Economic Development Or registration documents from the relevant state government offices Yei.
- Copies of valid vehicle Logbooks. Please do not attach original logbooks.
- The service provider must have a valid registration and permanent office in Juba South Sudan.
- Must be duly registered with sufficient fleets able to respond to FCA vehicle hire needs as and when called upon.
- The fleets must be in good condition, well fitted with ACs and suitable for the nature of roads in locations above.
- Bidders are MUST enclose copies of three contracts for taxi services with reputable NGOs within the last 12months (July 2018 to August 2019)
- <u>Sub-contractors/brokers and companies without an operational office in Yei are strictly **NOT** allowed to bid. Only contractors with an operational office in Yei are encouraged to participate in this invitation to tender.</u>

#### The Procurement committee shall undertake selection process based on the following criteria:

Criteria	Max Score
Price based on the current context. Tenderer that offers best value for money will be awarded 75 points.	80 points
Demonstrated experience. Enclosing of 3 previous contracts will be awarded 20 points. 2 contracts will	20 point
be awarded 10 points and 1 contract 5 points.	

Legal Compliance: Any company that will enclose expired company registration certificates will be disqualified from further evaluation.
