## **Background**

Action Africa Help International (AAH-I) is a nongovernmental and nonprofit making Organization operating in South Sudan with a mission to support disadvantaged Communities to sustainably improve their standard of living through Community empowerment approach in partnership with stakeholders. AAH-I implements Primary Health Care, Agriculture, Humanitarian aid projects and Capacity Building.

AAH-I South Sudan is calling for quotation for provision of Medical Supplies Warehouse Facility within Juba. AAH-I therefore, invites interested companies to make an offer based on the conditions stated in this call for quotations.

# Requirements

- The warehouse facility should have a volume not less than 900 cubic meters, with a height not below 4 meters to allow for adequate ventilation
- It should have metallic shelving for bulk storage with each shelve height not below
   1Meter (adjustable shelving would be preferred), width between 1.5 meters to 2 meters, length depending on the size of the storage unit
- Spacing between the shelving racks to allow for a walkway during inspection, moving of cargo to and from the shelves should not be below 1.5 meters in width
- It should have temperature controlled environment with the provision of temperature monitors (wall thermometers and AC units)
- Double entry points (multiple would be preferred since 900 cubic meters is a large space if
  it is one block, if multiple warehousing units then one point of entry and exit) one for
  entry and one for exit
- CCTV monitoring would be desirable.
- Office desk and chair for the officer(s) who will be coordinating from the warehouse
   These should be able to accommodate 2 officers
- Adequate interior lighting as well as outdoor security lighting
- The warehouse should be in a fenced (wall perimeter concrete fence) to ensure proper security
- Shower facilities and toilets both for labourers and officers is a must
- Fire suppression system in place to mitigate or limit damage in the event of a fire (not fire extinguishers but a more robust fire suppression system)
- The facility should be insured against fire, burglary and general risks with reputable insurance company.
- The facility should be permanent not temporary in structural nature
- Adequate compound space to permit for parking of multiple 40MT trucks at a given time
- Within the geographical local of Juba central is a must for easy coordination not beyond a 15 Km distance from the city centre and UNHCR HQ.
- Adequate drainage systems in place to avoid flooding in the event of rain
- Power should be 24 hours a day as a must
