Introduction;

Action Against Hunger has been operational in what is now South Sudan since 1985, responding to both chronic and acute humanitarian needs. Action Against Hunger addresses multifaceted crisis through implementation of multi-sectoral interventions in Nutrition, Health, Food Security and Livelihood, WASH, and Protection services to vulnerable communities across three States in South Sudan i.e. Warrap, Northern Bar el Ghazel and Jonglei States. To achieve positive impact in its efforts, Action Against Hunger wishes to enhance its collaboration with National actors and hereby launches a call for partnership with NNGOs in South Sudan.

ACF aims to collaborate with South Sudan National Non-Governmental Organizations that are well-positioned to address the Countries' humanitarian and Capacity building challenges.

Objective;

An organization with direct lived experience in providing integrated multi-sectoral interventions to conflict and flood affected populations play a primary role and whose objectives and activities are focused on responding to the needs of IDPS, returnees and/or related communities."

By working with the national organizations which are embedded in local communities, ACF aims to foster sustainable, inclusive, and impactful change, driven needs and priorities of the communities and the country.

Eligibility Criteria;

The call is open to national non-governmental organizations with long-standing experience in humanitarian and development in South Sudan. Eligible organizations must demonstrate:

- Legal Status: Must be a legally registered organization and operating in South Sudan.
- Bank Account: Must have a functional bank account and financial management system.
- Experience in delivering multi-sectoral interventions: Demonstrated experience in Health, Nutrition, WASH Food Security and Livelihood, Peace Building and governance, and Protection programming.
- Operational Track Record: The organization should be in good standing in the communities in which they serve.
- No Conflict of Interest: Must not have any conflicts of interest that would prevent fair and transparent participation

Application Process;

Interested NNGOs are invited to submit an Expression of Interest (EOI) by 20 November 2025. All applications should be typed written in English, Times New Roman Font, Font size 12, single spacing. The EOI should be concise, and include the below Required Content:

Organizational Profile:

- A brief overview of your organization, including its mission, vision, legal registration details (with copies attached), organization's physical address (in the states/counties) and geographical reach.
- Full name, title, email address, and phone number of the primary contact person.
- Provide examples of the work you have designed and implemented in the last 3 years

Motivation for Participation:

- Explain why your organization is interested in this partnership and how it aligns with your strategic goals.
- How do you envision this program/partnership contributing to your organization's goals and impact?

Current Capacity Assessment:

- Briefly describe your organization's current strengths and areas for improvement across key domains (leadership, programs, external relations, finance, administration, logistics, advocacy)

Anticipated Community Impact:

- Describe how collaboration with Actin Against Hunger will strengthen your organization's capacity and contribute to your humanitarian efforts.

Declaration:

- Declaration that your organization is not affiliated with political parties and does not engage in partisan activities. Declaration should be signed by the Executive Director and stamp

Submission Instructions;

Interested applicants should submit only electronic copies of their Expression of Interest, in a single PDF document, signed by the Executive Director of the Civil Society Organization submitted via this email address: ACF-Partnership@ssd-actionagainsthunger.org.
