About the role

It supports country programme to deliver on all aspect of partner financial management with a specific remit of ensuring timely delivery of partner procurement, budget and financial compliance on partner grants. In this role, you will have overall responsibility for maintaining accurate and update partner budget, financial and procurement reports and records, support partner internal and external audits and provide financial and procurement related support to Christian Aid staff and partners throughout country programme cycle. The role plays a key role in budgeting for new grants and during new programme development. In order to deliver excellence in finance and operation in the field, it is expected you will provide closer field support and annually undertake field trips in deep field locations prequalifying service providers, developing MOUs and undertaking market surveys in support of partner and CA overall operation in remote areas. Where appropriate you will also support admin and HR functions when delegated.
