## **Call for tender for supply of community Based FM Radio Stations (Studio and transmission equipment).**

Community Empowerment for Progress Organization (CEPO) is a South Sudanese civil society organization whose goal is to strengthen and promote the capacity of society in peace building, security reform, cultures of human rights, protection, democratic principles as well as livelihoods.

CEPO invites tenders from locally registered companies for supply and delivery of two Community Based FM Radios; their equipment and transmissions set up and renovation of structures for the FM Radio stations in Lainya and Morobo Counties of Central Equatoria states.

### **Objective for the Broadcast service**

The main objective is to establish two Community based FM Radio Stations in Lainya and Morobo Counties to help in creating awareness on peaceful co-existence and social cohesion. This is to fulfil the objective of the RSRSTF and IOM led Consortium, which aims at creating peaceful, and conducive environment for refugees and IDPs to return to their own villages to rebuild their lives.

### **The broadcast service tender must provide the following in details:**

1. Broadcast studio equipment including mixer, monitors, mics, headphones, computer, etc.
2. FM transmitter, and other associated equipment.
3. Studio soundproof
4. Furnishings, lighting etc.
5. General electrical wiring
6. Portable recording equipment.



## **The Role of the broadcast service tender**

1. To specify the works and equipment. The project manager will review this and any improvements and or changes recommended by **CEPO**.
2. The broadcast service tender will supply the FM radio equipment
3. Undertake procurement.
4. Undertake installation.
5. To make best use of 3 volunteers from the community to complement the work during the entire process of the installation.
6. To handover the completed FM Radios in Lainya & Morobo with equipment manuals and written description of installation.
7. To provide a technical briefing on the completed FM Radio installation & operation to technicians/community volunteers.

## **Tender Requirements & eligibility**

1. The Company must be a legally registered entity with Ministry of Justice; through the Registrar of Companies in which it has been issued with valid licenses of legal operations in South Sudan.
2. The Company must be a member of Chamber of Commerce issued with a Membership Certificate.
3. The company should have been issued with Operation licenses by the State Authorities allowing the company to operate within Central Equatoria State.
4. The Company should have obtained a Tax Identification Number (TIN) from Ministry of finance through the South Sudan Revenue Authority (NRA) with good experiences of tax remittances.
5. The Company should have obtained with clear location, obtain a letter of No Objection from the Criminal Investigation Department (CID) for free operation after verifying the company's BOD.
6. Examples of previous work, preferably of a similar nature to this project.
7. Contact details of two independent references.
8. Employee(s) at least two who will undertake the work (name, skills, experience) provide Resume.

Tender may suggest suitable equipment they have on stock for establishment of a community based radio station. Please note that we are not specific with the make or model of equipment. All we need is the equipment that takes into account the latest technological needs of a broadcasting radio station suitable for a rural community in South Sudan.
