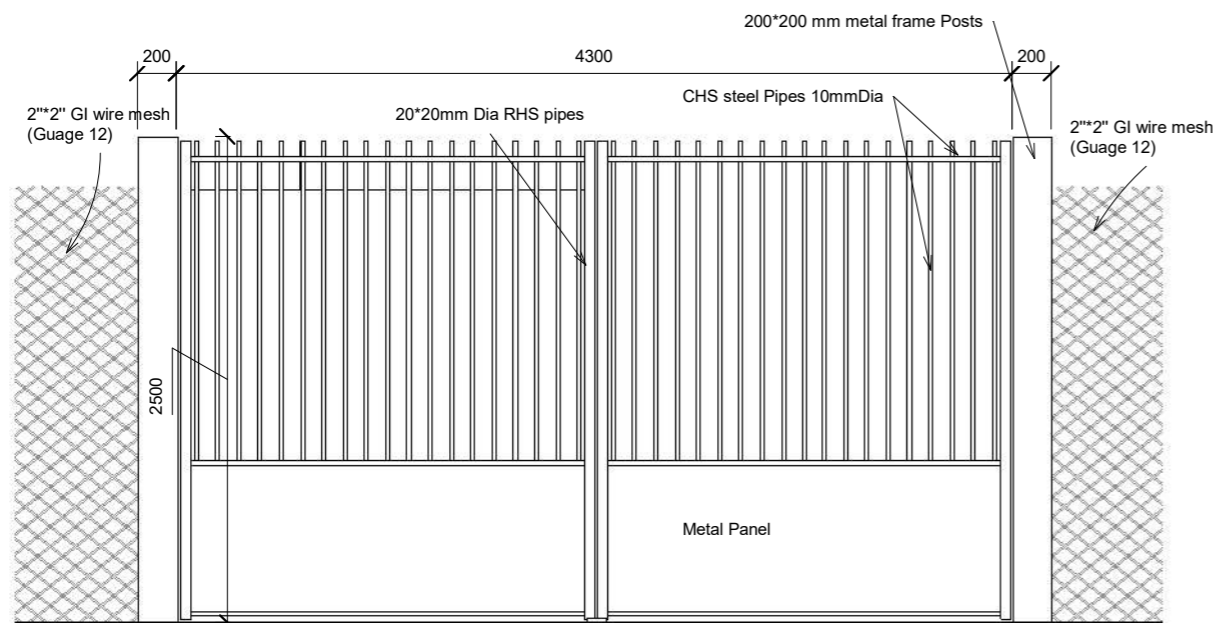

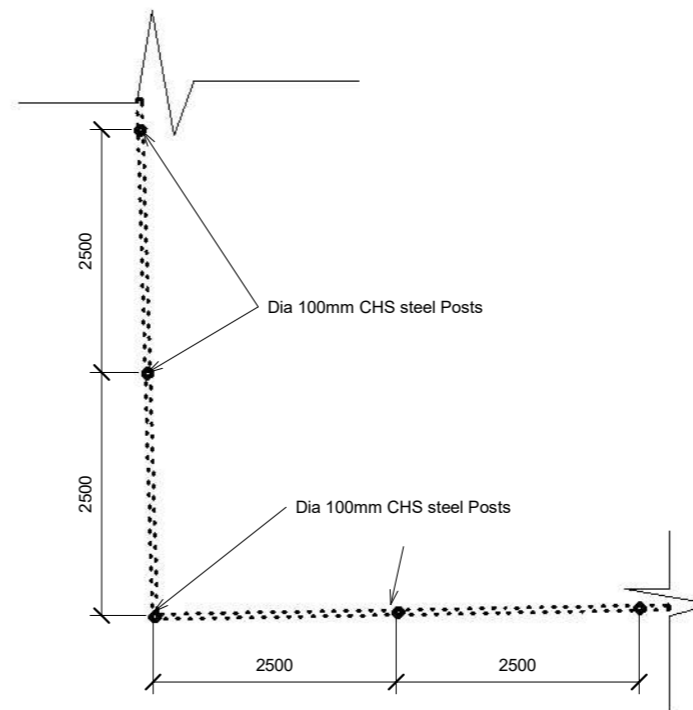
FENCE FRONT ELEVATION

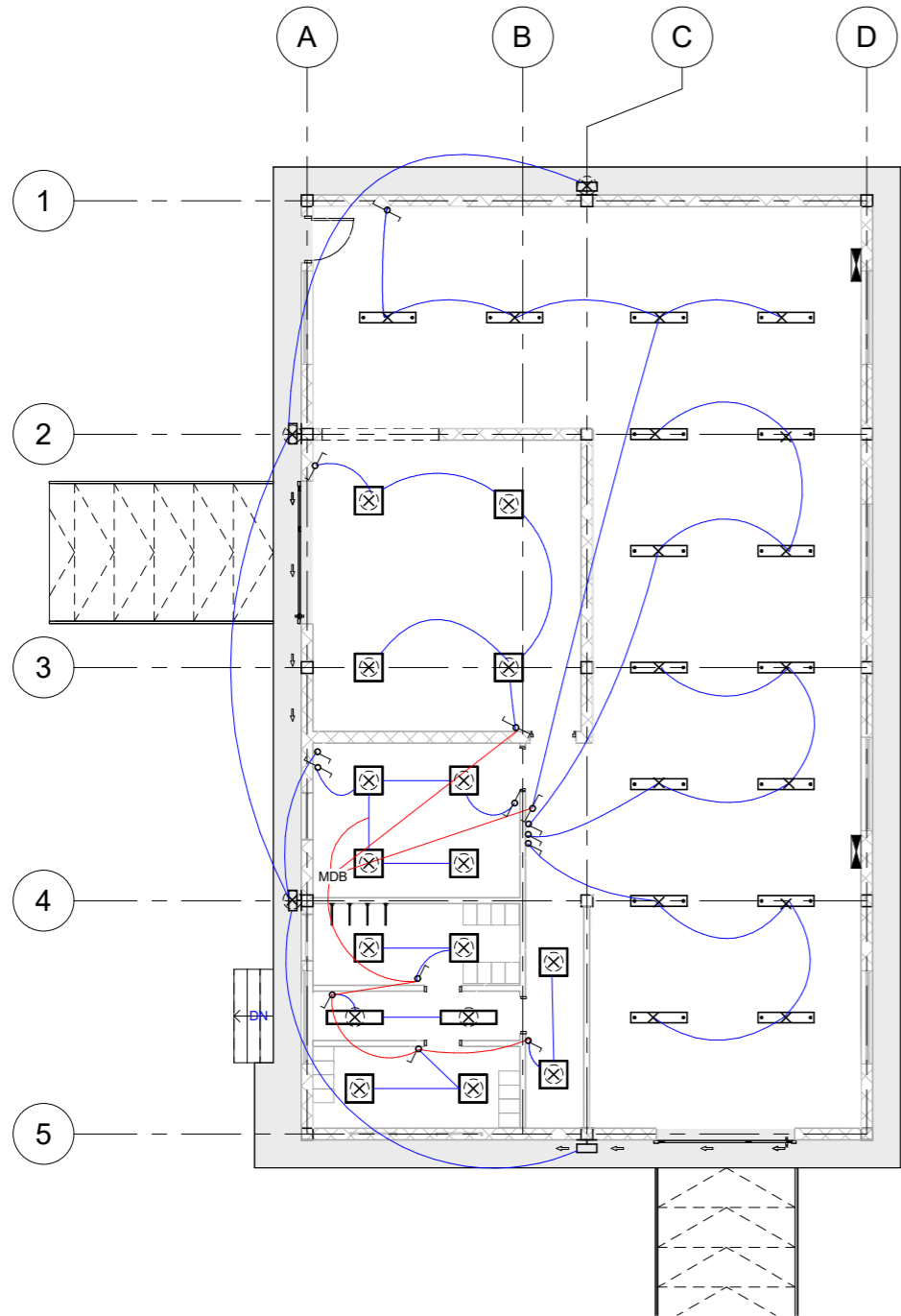

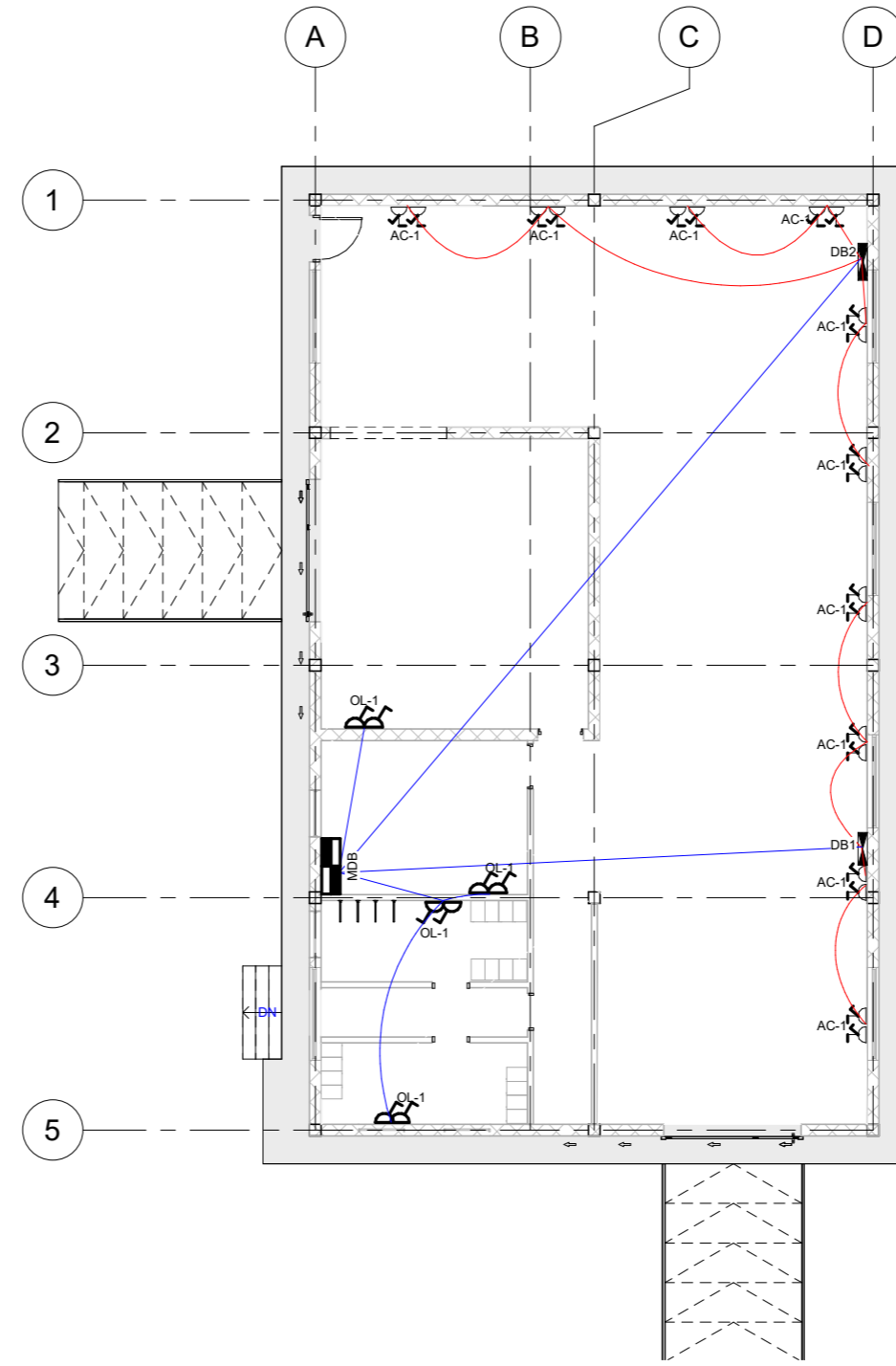
