

TECHNICAL REQUIREMENT FOR PROVISION OF MEDICAL SERVICES 2021/22

INTRODUCTION

World Relief South Sudan is the South Sudanese branch of World Relief, an international nongovernmental organization dedicated to partnering with the local church, to see the most vulnerable people transformed to economically socially, and spiritually. Since 1998, World Relief has been working with the local church to address humanitarian and development needs related to Health, Nutrition, Food Security, and Livelihoods (FSL), WASH (Water, Sanitation and Hygiene), Protection, Disaster Risk Reduction, (DRR), and Church Empowerment for Community Development.

World Relief South Sudan (WRSS) intends to contract a competent, suitable, and qualified Medical Insurance firm to:

a) Provide medical services to the national staff and their authorized dependents for a period of one year.

1. LOCATION

The services will be executed across our operational areas in the country which includes: Juba, Ibba in Maridi State; Bentiu and Koch in Northern Liech and New Fangak in Fangak State. The services will also include visitations to other medical providers in the wider East Africa countries.

2. STAFF NUMBER

WRSS has over **60 staff** (Juba-based or relocatable) spread out across the above mentioned operational areas in the country. Actual number of staffs who will potentially need medical coverage will be arrived at once bids have been submitted.


3. SCHEME OF COVERAGE

The medical cover should provide options for the employee and dependents. Life cover will only apply to the principle member.

4. OBJECTIVE OF THE MEDICAL INSURANCE SERVICES & LIFE COVER

The objective of the scheme is as below:

- i) Provide quality medical services for the staff and their dependents.
- ii) Avail appropriate medical facilities in the different locations of our operations at reasonable market costs.
- iii) Provide agreed health professional consultancies to WRSS staff and their dependents.
- iv) Provide emergency health services to WRSS staff and their dependents on agreed terms.
- v) Provide a competent contact person who shall be in charge of the WRSS account.



- vi) Provide a competitive Life Cover including death, critical/long term illness and disability limitations.
- vii) Provide medical evacuation services from field locations to Juba and Juba to other locations based on need.

5. DETAILED SCOPE OF SERVICES

The requirements and scope of services shall comprise of the following as prescribed in the matrix below;

- i) Bidder's company profile including company structure and organizational set up.
- ii) Full technical proposal.
- iii) Statement of company experience in providing similar services.
- iv) Latest Audited Financial statement for South Sudan operations.
- v) Legal documents including valid tax clearance certificate permitting bidder to operate in South Sudan
- vi) A list of some of the key organizations that your company has served over the last 3 years that can be reference checked.
- vii) Cost proposal for Medical cover options (both in & out patients), as well as Life Cover. The two cost proposals should be separate from each other.
- viii) List of current hospitals/clinics and copies of running agreements/contracts that bidder has with the facilities.
- ix) The proposal should take into account consideration of the desired minimum medical benefit table outlined below.
