**Project Background:** 

The purpose of the Afia Water, Sanitation and Hygiene (WASH) is to expand gender-transformative sustainable access to basic safe drinking water, basic sanitation coverage, and increase uptake of key hygiene behaviors to improve health and household resilience in accordance with USAID/South Sudan's Strategic Framework. Over 5 years, the Afia WASH Project intends to implement WASH improvements across the following 13 counties in South Sudan - Mayendit, Leer, Panyijar, Jur River, Wau, Kapoeta North, Budi, Baliet, Ulang, Akobo, Uror, Duk, and Pibor.

**Position Summary:** 

Reporting to the Regional Program Manager (PRM), the Driver will provide safe transport and logistics services for the Afia WASH Project. The driver will adhere to all traffic laws and DT Global Western Bahr el Ghazal South Sudan safety rules, transport guidelines, and policies. The driver will work in close collaboration with the field office based station and operations and program staff in Juba, as needed. The driver will also receive security briefings from, and regularly coordinate with, project security staff. They may also be required to conduct trips outside their primary duty station in support of project implementation.

#### **Duties and Responsibilities:**

- Drive an assigned project vehicle defensively and adaptively
- Maintain vigilance to ensure safety and avoid danger
- Responsible for vehicle cleanliness and reporting/ acting upon vehicle maintenance needs
- Perform daily and weekly safety and maintenance checks for their assigned vehicle, as described in the Logistics and Operations manual or as directed by their supervisor
- Adhere to all traffic laws and DT Global Western Bahr el Ghazal State South Sudan security and safety procedures in driving, including the prescribed proper placement of safety equipment (e.g. first aid kit, fire extinguisher, etc.), limiting speeds to between 60 and 80 km depending on road conditions, taking smoothest roads reasonably possible, and other points contained in the Logistics and Operations Manual or as prescribed by their supervisor
- Responsible for monitoring when the assigned vehicle needs service (both as required per the vehicle's owner's manual and as needed)
- Ensure that service records are updated and regularly provide the PRM and the Finance and Admin Officer (FAO) with service records and kilometer logs
- Receive security briefings from project security staff; provide transportation and road safety updates to PRM as needed; and take necessary action as advised by project security staff
- Update the vehicle logbook daily basis (movement, refueling, services and repair) and send to PRM on monthly basis.
- Provide data for the monthly report for fuel and vehicle maintenance (e.g. quantity of fuel, kilometers driven during the month, service/repair done, etc.)
- Responsible for ensuring that no unauthorized passengers are permitted to enter the vehicle and institute the use of "Waiver" for all non-DT Global staff.
- Provide professional atmospheres for all passengers while traveling
- Assist in other operations and logistic duties as assigned by the PRM or Finance and Admin Officer (e.g. office maintenance, purchase, transport of goods, errands, etc.)
- Other tasks as assigned by supervisor
