Organization description

Purpose of the Position

The Pro-bono lawyer will report to the program manager who will be his/her immediate supervisor

Main responsibilities

 Prepare Legal services activities' work plan and implement the activities included in the work plan according to the available scope of work and submit report weekly or monthly to his/her line manager.

 Study constitution, statutes, and decisions regulations, ordinances of quasi-judicial bodies to determine and draft legal documents such as wills, patent applications, leases, and contracts.

- Present evidence to defend clients or prosecute defendants in criminal or civil litigation.
- Prepare legal briefs, opinions and file appears in state and federal courts of appeal.
- Negotiate settlement of civil disputes in greater Bor and Wau.
- Confer with colleagues the experience in appropriate areas of legal issues to establish and verify Cases for legal proceeding
- Search and examine public and other legal records to write opinions or establish ownership.
- Provide legal assistants where necessary to the vulnerable community members of Bor and Wau.
- Perform administrative and management functions related to the practice of law.
- Act as agent, trustee, guardians or executor for business or individuals
- Help in developing federal and state programs, draft and interpret laws and legislation to establish enforcement procedures.
- Ability to be flexible and use excellent judgment in challenging environments
- He/she will perform any other relevant duties assigned by His/her line manager.
