### PROJECT BACKGROUND:

Life in Lulu is BBC Media Action's long-running radio drama in South Sudan. In the past the storylines focused on beliefs about health, conflict, and peaceful co-existence. To date, 8 series of the drama have been produced and BBC Media Action is preparing to produce an additional 2 series. These will focus on youth civic engagement, including sexual and gender-based violence. The drama will be produced in local languages and broadcasted nationally and across community stations, use digital platforms and work with CSOs to implement community outreach activities.

## OVERALL, PURPOSE OF THE JOB:

The sound editor will be responsible for the high quality recording and editing of radio drama and PSAs in all 6 languages and maintaining SFX libraries.. Will be responsible the Production – (the recording of all sound on set or on location) and Post-production (the

balancing, mixing, editing and enhancing of pre-recorded audio) of all drama series ensuring highly technical and quality audio recording.

#### Main Duties:

- Under the supervision of the Head of Production and Training, and working with Drama Producer and Script writer, will take responsibility for a range of sound and video recording and editing - this include location recording of radio dramas, instudio recordings, public service announcements, or any other potential output on any platform.
- Be responsible for post-production editing of programs, sound balancing of programs for broadcast, and delivery of final versions to deadline.
- Work with relevant teams to plan of production, including recces, equipment preparation, logistics, and consideration of health and safety issues from a technical recording perspective.
- Along with the rest of the technical production team, take responsibility for technical safety in the studio and on location, and operate all equipment safely adhering to safety regulations.
- Along with the rest of the technical production team, take responsibility for proper use, care and storage of all recording and editing equipment.
- Keep up with the latest recording and editing advances, methods and trends and implement them into your work.
- Contribute to content creation by participating actively in brainstorming and ideation activities.
- Assist in completing all relevant pre- and post-production paperwork
- Logging of all recordings
- Sound design for all programmes
- Adhere to Safeguarding policy and always working with vulnerable people.
