OVERALL, PURPOSE OF JOB:

The Producer will be responsible for delivering the specific language edition of a factual radio programme focussed on the issues outlined above. This includes research, plan, present and produce the programme.

MAIN DUTIES:

- To produce episodes of the GBV factual radio programme in English Language
- To actively participate in the planning process before and after launch: bringing ideas for topics, programmes and map out contributors.
- To work to an agreed brief to research, plan, produce and present each episode of the programme in English.
- To manage own logistics to produce programmes: travel, budgets, risk assessment, permission letters etc with support and advice from the Project Manager and Snr Production Manager.
- To ensure written or verbal consent is gained from every contributor before recordings begin and that the record is kept centrally at BBC Media Action
- To ensure the local language in your programmes is clear and correct and the language and terminology is appropriate for our audience.
- To ensure all recordings are of a high technical standard and conform to BBC editorial standards and policy.
- To submit all scripts including transcriptions of audio to the Snr Production Manager for approval and sign, before mixing the final version of your programme
- To contribute to PSAs radio content
