- Develop Standard Operating Procedures (SOPs) and/or guidelines for PC NTD interventions Mass Drugs Administration campaigns, Supply Chain Management, Trachoma Trichiasis surgery, Lymphatic Filariasis Morbidity Management Disability Prevention and Water Sanitation Hygiene education.
- Develop, review and update training materials for PC NTD interventions, act as facilitator or trainer at different levels of the national health system when required.
- Collect feedback on the SOPs, guidelines, training materials and implementation of the training plans and formulate recommendations to the PC NTD Director.
- Review tools for macroplanning, county-level microplanning.
- Identify capacity gaps for the delivery of the PC NTD programme and make recommendations
- Develop the programme M&E framework, and support the implementation of the M&E framework, including the integration of programme indicators in the DHIS2. Make recommendations for undertaking corrective measures where necessary
- Support in the establishment and application of a data management system, with checks and balances, to assure quality data reporting. Support preparation of quarterly project reports following agreed reporting timelines, review draft reports
- Develop a training module for the integrated M&E and support the roll-out of the training plan.
- Develop management tools for Supply Chain Management and logistics.
- Lead on the development and application of the Supervisory Coverage Tool and Data Quality Assessment.
- Review Coverage Evaluation Survey (CES) protocol, oversee the implementation of the CES and review report drafts.
- Plan the Lymphatic Filariasis Transmission Assessment Surveys.
- Lead on the development of protocols for Lymphatic Filariasis transmission assessment surveys, in collaboration with stakeholders.
- On the planning of Onchoceriasis elimination mapping, in collaboration with stakeholders.



- Support the management of the Joint Application Package (JAP) and the Tool for Integrated Planning and Costing (TIPAC).
- Oversee project implementation with all levels of the health system (national, state and county) in order to ensure timely implementation of annual work plans.
- Establish and maintain good relations with key stakeholders
- Participate in coordination meetings (National, State, NTDs sub-committees) as agreed with the Director for PC NTDs.
- Collaborate with the CBM Country Office team, the CBM NTD Technical Coordinator and CBM South Sudan NTD team, the CBM NTD Team as required.
- Liaise with national and international programme stakeholders, in collaboration with the national PC NTD Director.

- Master's degree in Public Health or other health/medical sciences,
- Additional professional courses in project management and/ or monitoring and evaluation is desirable
- Minimum of 5 years' experience in a similar position, preferably in a field-based position with an NGO
- Experience with public health programs and liaising with appropriate government structures (MoH, regulatory bodies).
- Proven ability to work effectively in a team environment and matrix reporting and collaboration structure
- Experience building and leading teams
- Knowledge of project cycle management, including budget monitoring
- Proven knowledge in technical aspects of Neglected Tropical Diseases (NTD) and/or treatment strategies
- Proven knowledge in technical aspects relating to the PC NTDs particularly onchocerciasis, lymphatic filariasis, schistosomiasis and trachoma, including Morbidity Management Disability Prevention (MMDP).
- Experience in Disability Inclusive Development would be advantageous
- Profound communication and relationship building skills
- Excellent knowledge of Microsoft office, and a working knowledge of Geographic Information Systems is an advantage
- Professional proficiency/fluency in English, proficiency in other languages desirable
- Willingness and ability to travel for field visits as required
- Identification with Christian values and the mandate of the CBM
