

JOB PURPOSE:

The TeamUp Coalition Coordinator is a member of Save the Children's team in South Sudan. The position is designed to provide technical guidance, capacity building and support to the trainers and facilitators for the TeamUp programme. TeamUp is an inclusive PSS group intervention with structured movement-based group activities based on play, movement, and body awareness for children, Teamup decreases stress and increases wellbeing. Also, the Coordinator is expected to provide inputs and guidance throughout the project/s lifecycle, from community assessment to proposal development and design, through implementation, monitoring and evaluation.

Under the supervision of the CP technical specialist with technical support from the MHPSS technical Specialist, the post holder will build capacity for the implementation of TeamUp programme and support the mainstreaming of MHPSS across a portfolio of projects.

KEY AREAS OF ACCOUNTABILITY:

Work closely with the CP technical specialist to ensure the quality implementation of TeamUp and other related MHPSS activities

Capacity building

- Provide technical guidance for the quality and timely programme implementation of the project/s
- Capacity building- prepare and conduct trainings, coaching, mentoring and on-job training to teams including volunteers
- Continuous support supervision to the trainers and facilitators

Supervision, Reporting and Coordination

- Monitor, supervise and assess the quality of the implementation of TeamUp activities, ensuring that staff are using the recommended guidelines and tools, and are able to provide quality PSS services
- Develop and manage weekly & monthly supervision schedules to ensure relevant staff receive adequate field supervision and that catchment populations are offered services according to intervention protocols
- In close working relationship with the various sector teams, support the implementation, monitoring, follow up and reporting on related activities that include trainings, workshops, facilitation, data collection, etc.
- Mapping of internal and external services, ensuring a good working relationship with other agencies for the referral of children, caretakers/families in need of further support
- Coordinate with logistics to ensure timely and safe delivery of associated supplies
- Liaise with County and State authorities, and representation at field site level (i.e. community meetings, MHPSS TWG, PSS WG, Child Protection sub cluster, or as required
- Perform other functions and initiatives that may be assigned by Line Manager
