#### BACKGROUND/INTRODUCTION

## General notes.

## General notes.

- 1. The Household latrine construction activity shall strictly be executed during dry weather condition and if heavy rain starts at the targeted project locations, the vendor will be paid by IRSS for the completed work whereas the remaining latrines construction shall resume during dry season. There will be no financial implication as a result of the weather conditions.
- 2. Rates and process- the contractor is deemed to have allowed in the rates and prices inserted in the bill of quantities for all charges in providing labour, equipment, materials, transport, supervision and profits in carrying out and completing the work.
- 3. Child labour (any person under the age of 18 years) The contractor shall certify that no forced or indentured child labour is used to carry out any kind of job in part or whole during the period.
- 4. Protection of the public Contractor to put in place buffer zones and warning signs, all as necessary to protect the public clear away from the site.
- 5. Decommissioning (debris, rubbish and clearing away etc) The contractor shall keep the site free from all debris and wastes arising from the execution of the work such as sharp objects that could cause injuries.
- 6. Contractor to ensure all materials put in the execution and completion of the work should conform to the recommended standard and qualities as per the building regulations.

a) Tasks and expected activity implementation period

The contractor is expected to carry out the job accordingly, while assigning specific and clear task of jobs to specific team group e.g. Technicians and masons. The work is expected to take maximum 45 days.

b) Roles and responsibilities of Contractor and IRSS

## The contractor:

- Is solely responsible for provision of all the materials, services, transportation and personnel needed for the work, ensure that all materials, services and personnel conform to approved grade, skills and standards.
- Responsible for the team deployed for the work, all their basic needs are catered for, should not interfere with the work.
- Every three days' update to WASH officer in the field of work progress, Challenges and constraints should be reported and challenges addressed.

## **IRSS**:

- Responsible for coordination with authorities, communities and other stake holders in all matters pertaining to the construction work.
- Conduct regular monitoring visits, inspection of all materials and services involved in the work.
- Will provide guidance and advice and support as deemed necessary.

## Interface

- Ensure there is very good line of communication and coordination between Islamic relief and the contracted company.
- All communication and coordination should be done through the company focal person designated for that in the field and the organization's officer in the field.
- No direct communication between any company staff and IRSS, unless an informal one.
- IRSS engineer can be directly contacted any time for consultation and advice.

Contractor to report on each phase of work successfully completed, this includes: Clearance, Pit excavation, construction, decommissioning and handing over.

- Final inspection will be jointly conducted with DPU and Community leaders. In case of defaults in any component, has to be rectified before final handing over is done.
- After the facility is handed over, IRSS will carry out post construction monitoring for a period of three months before the liability (retention) money is settled.
